

#### National Priorities

National Priority Areas (NPA) – These are required and account for 30% of available funding

- Combating Domestic Violent Extremism 7.5% (moved as Competitive through State)
- Enhancing Cyber Security 7.5% (moved as Competitive through State)
- Intelligence & Information Sharing 5%
- Protection of Soft Targets & Crowded Space 5%
- Addressing Emerging Threats 5%





Regional Planning

REPAC recommended removing CCP from a carve-out project to be competitive with the rest of the working group and only have regional planning to be a carve-out.



## SHSP Scoring Guidelines 📩

- SHSP Guidelines and Factors
  - Nexus to Terrorism: Establishes correlation to terrorism preparedness and/or prevention
  - Regional in Scope: Benefits region as a whole vs. few or one jurisdiction
  - Ongoing Sustainment: One-time or sustained by sub-grantee vs. continued SHSP funding
  - Capability Gap: Need identified in exercise, real world event, and/or THIRA/SPR
  - Reasonable Budget: Amount requested aligns with project

Overall Quality: Assessment of project
