Dear Mr. Saenz:

We have reviewed the transportation conformity documentation for the 2009 amendments to the Dallas-Fort Worth area's Mobility 2030 Metropolitan Transportation Plan (MTP) and revisions to the FY 2008-2011 Transportation Improvement Program (TIP), including the supporting documentation for the non-metropolitan area portion of the 9-county Dallas-Fort Worth nonattainment area. Based upon our review and consultation with the U.S. Environmental Protection Agency (EPA), the Texas Commission on Environmental Quality (TCEQ), and the Texas Department of Transportation (TxDOT), we hereby find that subject to the enclosed comments, the 2009 amendments to the Mobility 2030 MTP, the revisions to the FY 2008-2011 TIP, and supporting documentation for the non-metropolitan area portion of the 9-county Dallas-Fort Worth non-attainment area meet all the requirements for making a joint conformity determination under the Clean Air Act Amendments of 1990. In their letters of July 23, 2009, August 13, 2009, and August 19, 2009, EPA, TCEQ, and TxDOT, respectively, indicate that they have no unresolved issues concerning this conformity determination. The conformity determination and procedures used to make this determination are in accordance with the provisions of the transportation conformity rule (40 CFR Parts 51 and 93), dated August 15, 1997, as amended.

The Federal Highway Administration (FHWA) acts as executive agent for the Federal Transit Administration (FTA) on Plan and TIP air quality conformity determinations. Accordingly, this letter will serve as the joint FHWA/FTA conformity determination. Please provide copies of this joint FHWA/FTA conformity determination to the North Central Texas Council of Governments, the Dallas Area Rapid Transit, the Fort Worth Transportation Authority, the Denton County Transit Authority, and the Texas Commission on Environmental Quality.



Please note that this action does not restart the Dallas-Fort Worth area's four-year MTP and corresponding conformity determination update cycle. However, this conformity determination satisfies the requirement that conformity be re-determined within 24-months of the following actions concerning the State Implementation Plan (SIP) for the Dallas-Fort Worth area, associated with the 1997 8-hour ozone standard:

- EPA's April 7, 2008, adequacy determination of the motor vehicle emissions budgets contained in the Attainment Demonstration SIP
- EPA's December 8, 2008, approval of the Reasonable Further Progress SIP
- EPA's February 13, 2009, Conditional Approval of the Attainment Demonstration SIP.

- Regional Significant Arterials (RSA) Listings: Please ensure that the listings included in the documents (i.e., Mobility 2030-2009 Amendment and 2009 Transportation Conformity Determination) are consistent (e.g., DAL\_RSA: 04-09-2009 (2009 TR) and 04-15-2009 (MTP) and FTW\_RSA: 04-09-2009 (2009 TR) and 02-27-2009 (MTP))
- 3. Pages 476-477 (Regional Significant Arterials): The Federal Functional Classification year should be updated.
- 4. Regional Toll Network Analysis information should be included in the MTP.

- 5. Future submissions of Appendix D should include projects with revisions (only). Additionally project phasing may be removed from Appendix D.
- 6. CSJ 0422-05-001 is approved subject to an edit to the RSA Table to correct a difference between the 2030 MTP-2009 Amendment, 2009 Transportation Conformity Determination and the revised 2008-2011 STIP.
