1. **Summary from last meeting**

The meeting summary from the October 2, 2014 meeting was accepted as presented.

2. **FY2015 IDDE Project Update**

a. **IDDE poster series**

The IDDE poster series – a companion piece to the IDDE poster completed last project year, will use images from the existing poster, verbiage from the IDDE Field Guide, and be sized 11" x 17". NCTCOG staff will work up drafts to be distributed, including potential wording, ideally before the next meeting in April. The preference is to have these posters and the existing one available through the Cooperative Purchase in the future.

b. **Spanish translation for the IDDE video**

The City of Carrollton will provide Spanish translation of the script and a narrator for the IDDE video. Translation work on the video will begin soon.

c. **The standing project – the dry weather field screening/IDDE basics workshop**

The City of Carrollton will host the Spring 2015 IDDE Basics/DWFS Workshop. The City of Fort Worth will act as the instructor with possible participation from other cities.

d. **Industrial Inspector Workshop**

The oft-delayed Industrial Inspector Workshop (a project carryover from FY2014) will take place at the Denton Municipal Airport on January 14th. Mock inspections will be at the airport, and Peterbilt and TetraPak manufacturing facilities.

3. **Advanced IDDE Workshop**

5. Case studies from Irving and Grand Prairie


