

# SUMMARY

#### **Public Works Council**

1. **Welcome and Introductions**. The Public Works Council (PWC) Chair will welcome everyone to the meeting.

#### ACTION/PRESENTATION/DISCUSSION ITEMS

2. **Meeting Summary**. The <u>November 12, 2015</u> meeting summary is available online for review. Approval will be sought at the meeting.

The meeting summary was approved with no comments.

3. **FY 2017 Public Works Program Discussion.** NCTCOG staff will request the Council's input on the FY 2017 Work Program, and will update the PWC on the FY 2017 cost share distribution.

NCTCOG staff discussed the current FY2016 Work Program with the PWC and requested ideas that could be added as additional activities to the FY2017 Work Program. The group discussed the idea of trainings to be geared towards contractors, and to include courses on licenses, equipment, certifications, and safety.

4. **Public Works Construction Standards**. NCTCOG staff and the Public Works Construction Standards Subcommittee will brief the PWC on the overall progress of the update to the Construction Standards made by the review groups.

NCTCOG staff discussed the upcoming schedule for the Public Works Construction Standards and noted that the new release date will be delayed due to some issues that need to be worked through in some of the Construction Standards Divisions. The PWC received a handout with a detailed schedule and comments on each review group. The PWC will continue to review portions of the Construction Standards as the Public Works Construction Standards Subcommittee approves them.

NCTCOG staff will present an update of iSWM program activities including recent iSWM implementation workshops. NCTCOG staff will also update the PWC on the activities of the SPROW Subcommittee, including the membership of the subcommittee and the upcoming SPROW Education Forum to be held on March 31, 2016.

NCTCOG staff updated the PWC on the recent "Benefits of iSWM" meeting in Kennedale and noted that the City of Denton received their iSWM Silver level plaque at their February Council meeting. NCTCOG staff also talked about the upcoming Implementation Workshops and that they will serve to help cities complete the process of filling out the iSWM forms, at a more focused, hands-on level. NCTCOG will be releasing an RFP this year to procure for an iSWM consultant.

NCTCOG staff also announced that the SPROW Education Forum will be held on March 31, 2016 at the NCTCOG Offices. NCTCOG noted that registration filled up in two days so the event has been relocated to a larger room in NCTCOG's Centerpoint I offices, and that there are still spots left if PWC members would like to register.

6. **Public Works Roundup Planning.** NCTCOG staff will speak about the Annual Public Works Roundup and will ask for input from the PWC on the topic ideas generated thus far. The Public Works Roundup will be held in late May or early June this year.

NCTCOG staff presented the PWC with a list of 26 topics that had been collected from the PWC and other individuals so that the PWC could vote on their favorite topics. PWC members voted on the topics, and NCTCOG will be working to find presenters on the most popular topics. NCTCOG staff noted that a venue for the event is not confirmed yet, but that sponsorship information will be sent out shortly.

7. **Other Program Activities**. NCTCOG staff will provide an update on FEMA's Cooperative Technical Partnership (CTP) Program activities and the Floodplain Administrators/Community Rating System Users Group.

NCTCOG updated the PWC on the closeout of the Bear Creek Project in Southlake and Colleyville which will be completed by February 29<sup>th</sup>. NCTCOG staff briefed the Council on the upcoming projects in the Denton and Cedar watersheds and cities of Shady Shores, Corinth, and Irving.

NCTCOG staff mentioned that there are 2 upcoming Floodplain Administrators/CRS Users Group meetings scheduled. The first meeting on March 22<sup>nd</sup> will focus on a case study of Dallas' CRS Program, and the meeting on April 28<sup>th</sup> will focus on the ISO Specialist for our communities. Registration is available on NCTCOG's website.

The Council also received an update on the Cooperative Pavement Analysis program that NCTCOG has been working on. NCTCOG staff noted that the RFQ to procure for pavement analysis services would be released on March 1<sup>st</sup> and that after the contract is awarded later this spring, cities will be able to contract for pavement analysis service through NCTCOG's regional contract at a lower rate.

NCTCOG also noted that there are two pavement training classes coming up on April 5<sup>th</sup> and 6<sup>th</sup> and registration can be found on NCTCOG's Regional Training Center website.



#### **INFORMATION ITEMS**

8. **Public Works Emergency Response Team (PWERT)**. A PWERT representative or NCTCOG staff will give an update on recent PWERT activities.

Joe Trammel updated the group that PWERT became a working group and received the full amount of grant funding that they applied for in FY2016. He has been asked to speak at a conference in Tacoma, Washington because of the success of PWERT. The next meeting will be March 16, 2016 at 9:30am.

 Theft on Jobsites. Paul Causey will update the PWC on the Theft on Jobsites issue, and on the initiatives that the Association of General Contractors and NCTCOG have agreed to pursue.

Paul Causey, AGC Texas, updated the group on joint efforts with NCTCOG's transportation department to eliminate copper theft in DFW. Funding is needed, along with law enforcement encouragement.

10. **Texas Public Works Association Update.** A TPWA representative or NCTCOG staff will update the PWC on upcoming TPWA local events and meetings.

NCTCOG staff informed the Council that the new President of TPWA is Pam Salvador. The General Member luncheon will be held April 26, 2016. There are 4 upcoming roundtables scheduled during the month of March.

11. Discussion with AT&T. At the PWC meeting on August 27, 2015, a request was made by the Council to bring in local utility agencies to future meetings for approximately 30 minutes of discussion on field issues and how to coordinate more effectively. The Council will continue this initiative through a discussion with AT&T.

AT&T representatives Jarred Whittington and Linda Caram presented information to the Council about AT&T's 5 areas of service in DFW and provided a map with contact information for area representatives. They have implemented a new database to track all civic projects, to maintain time deadlines, and to communicate between project managers. Civic Projects include relocations, road adjustments, road improvements, and facility movements. PWC members asked AT&T representatives about contractor issues and suggested that scorecards also be filled out by the municipal customers who are working with the contractors.

#### OTHER BUSINESS AND ROUNDTABLE DISCUSSION

12. **Future Agenda Items**. PWC Members and NCTCOG staff may suggest future agenda items.

No future Agenda items were suggested, but the PWC requested that Oncor be the next utility company to come and talk with the Council about coordination.

13. **Roundtable Topics/Other Business**. PWC members and NCTCOG staff may share additional items as time allows.

Westworth Village – Working on a trail project.

Weatherford – Continual growth; 6 subdivisions under construction and more coming. Working on road/utility payment responsibility.

ACG Texas – Asked members if there is still trouble getting contractors for work.

Suggested creating a survey for municipalities to fill out and show their upcoming projects and costs which can be given to contractors so that they are aware of what work is going on.

Grand Prairie - Working on MacArthur expansion and CRS reverification.

Mesquite – Residential street bond program.


Irving – Southgate kickoff meeting.
