2. Regional Stormwater Management Coordinating Council (RSWMCC) Meeting Summary. The August 19, 2020, meeting summary is available on the web for viewing.

**4. FY2021 Cost Share Program.** NCTCOG will present the status of FY2020 cost share program.

Staff showed the cost-share participants for the first 6 weeks of FY21. Total commitments equaled 55% of the overall budget for the year.

**5. Roundtable Programs.** NCTCOG staff will present information on the post construction inspection roundtables and upcoming TMDL roundtable.

Staff provided a quick summary of the November 5th Post Construction Inspection Roundtable, and post links to the resources and presentation from that event to the website for review. ## **8.** News and Resources. NCTCOG staff will provide some informational items from related programs.

On October 22nd, the Secretary of the Interior announced the addition of 30 new national recreation trails to the National Trails System, including the Trinity River National Paddling Trail. The Trinity Coalition, in partnership with communities along the Trinity River and its branches, spearheaded this effort.

NCTCOG Environment & Development and Transportation Departments submitted a Flood Infrastructure Fund Category 1 application to the TWDB for \$1.5 million on October 19th for the Upper Trinity River Transportation and Stormwater Infrastructure Project.

Regional Flood Planning Groups (RFPGs) held their first meetings late October/early November. The Trinity RFPG met on October 27th and Lower Brazos RFPG on October 30th. These RFPGs will create regional flood plans by January 2023 and the TWDB will adopt a state flood plan by September 2024.

**9. Future Agenda Items**. RSWMCC Members and NCTCOG staff may suggest future agenda items.

No future agenda items were brought up.

**10. Roundtable Discussion**. Discussion of activities within individual jurisdictions and other topics as time allows.

Plano - Submitted permit application; it expires in December. They are working through IDDE issues with the Circle K petroleum leak. Circle K has completed their report and sent it to TCEQ for review. The city might have another potential clean-up site at a previous brownfield approved by the TCEQ as complete (clean).

Arlington - SWMP was approved. Will be posting three new positions shortly. Dallas - Working on their annual report, received comments on SWMP.

Fort Worth - Received annual report back in June. Staff is having problems visiting industrial facilities in person. Seeking help from Boston with the install of the trash wheel. Garland - Working on their annual report. Asked if anyone had any information about electronic submittal of permit applications. Arlington suggested that this was a question for your permit writer or Rebecca at TCEQ.

Frisco - waiting for SWMP review by TCEQ, installing a trash removal device. Lewisville - Utilizing the COG training portal.

Carrollton - Working on their annual report. SWMP has not been approved.



DART - Completed technical review. They were helping a consultant locate a gas leak under a DART parking lot. Tad is retiring from DART but may stay active in the area. Mansfield - Shared his experience with brownfield redevelopments that have been approved by TCEQ in Mansfield. They are working on their annual report.

**11. Schedule for the Next Meeting.** The next meeting date is scheduled for Wednesday, February 17, 2021.
