3. Approval of the 2024 International Fire Code Amendments. Advisory board Chairs will present the revised recommended 2024 International Fire Code amendments for RCCC approval. The RCCC will vote to recommend these amendments to the NCTCOG Executive Board for approval.

Evan Roberts, City of Forth Worth, made a motion to reconsider the 2024 International Fire Code (IFC) Amendments for changes to Appendix L. The motion was seconded by Jeremy Booker, City of Lewisville. The motion passed unanimously.

Attendees discussed the revised amendments to Appendix L of the 2024 IFC, including revisions to the Reason Statements following Section L101.1 and Section 104.13.1. Brett King, City of Carrollton, made a motion to adjust the Reason Statements to these sections. The motion was seconded by Warren Bonisch, WJE & Associates, Inc. The motion passed unanimously with one abstention from David Kerr, City of Melissa.

Dwight Freeman, City of Dallas, motioned to approve the recommended amendments to the International Fire Code with the discussed changes to the Reason Statements. The motion was seconded by David Session, City of Dallas. The motion passed unanimously with one abstention from David Kerr, City of Melissa.

4. Regional Codes Coordinating Committee FY2026 Membership. The RCCC will vote on members seeking reappointment to the committee and review nominations for new members. The committee will also vote on nominations for Chair and Vice Chair for FY2026.

Jack Baxley, TEXO Association/General Contractors Representative, made a motion to accept all public sector members seeking reappointment for a new two-year term. This motion was seconded by Evan Roberts, City of Fort Worth. The motion passed unanimously.
