Note: Contamination rate adjusted to better reflect the composition of the material that is delivered and processed by MRFs in the region. Only 75% of the weights of contamination categories including non-recyclable plastic, food waste, and other organics are considered. These weights are adjusted because during the sorting event non-recyclable plastic category included bulky plastic, a material that several MRFs in the region sort and sell. Also, food waste and other organics are often moisture rich, and their volume and weight reduced due to spillage and evaporation in transportation and handling of material at the MRFs.
