Upon a Motion by Councilmember Mendelsohn (seconded by Councilmember Justice), and unanimous vote of all members present, the Board approved Items 4 & 5 as presented.

#### Item 9 Resolution Authorizing Contract with Kimley-Horn and Associates, Inc. for the Federal Highway Administration Charging and Fueling Infrastructure Community Program Deployment Dream Team

This item was pulled from the Consent Agenda by Judge O'Hare for Individual Consideration.

Board authorization was requested to enter a contractual agreement with Kimley-Horn and Associates, Inc. to provide Deployment Dream Team services for the Charging and Fueling Infrastructure (CFI) Community Program project. The contract amount shall not exceed \$1,500,000 and will deploy up to 100 EV charging station ports on public-sector properties. The scope of work includes assisting the project team with permitting, zoning, utility coordination, and other processes that typically cause project delays. Kimley-Horn has committed to meeting a minimum 7.9 percent Disadvantaged Business Enterprise (DBE) participation goal for this project, which matches the DBE goal identified for this type of procurement. Funding for construction and installation of charging stations will be distributed through subawards to public sector agencies and will be brought for Board approval at a future date.

Judge O'Hare asked about the criteria for the grant. Mr. Morris explained that the grant was authorized by the Federal government. The criteria will be developed by the Regional Transportation Council and Transportation department, focusing on the proximity to vehicle recharging stations. An interlocal agreement will also be created. The user will pay the implementor for the electricity used to charge their vehicle. This item involves hiring a horizontal expediting team to create the procedures and permitting requirements used by cities to implement charging stations across various departments.

#### Item 10 Resolution Authorizing Agreements with Subrecipients for the North Texas Reliable Electric Vehicle Infrastructure Project

This item was pulled from the Consent Agenda by Judge O'Hare for Individual Consideration.

Board authorization was requested to subaward \$3.16 million in Federal Highway Administration (FHWA) funding for the North Texas Reliable Electric Vehicle Infrastructure Project. As shown in Table 1, this funding would be allocated to various subrecipients. Any remaining balance or released funds would be used to reimburse capital cost overruns, cover maintenance and operations expenses, and pay for other eligible pass-through costs, per FHWA guidance. The allocation of any unused funds to the subrecipients would not exceed 25% of each subrecipient's original award. The Regional Transportation Council approved subaward funding recommendations at its April 10, 2025 meeting.

Kelly Schmidt, Criminal Justice Program Administrator, presented the FY 2026 Criminal Justice priority projects for Board endorsement. She explained that NCTCOG has an Interlocal Cooperation Agreement with the Criminal Justice Division (CJD) of the Office of the Governor's Public Safety Office (PSO). Under this contract, NCTCOG is responsible for determining regional criminal justice priorities. Submitted applications were reviewed, discussed and scored by the Criminal Justice Policy Development Committee (CJPDC). Priority lists were then developed in each category and will be submitted to the PSO, which provides the funds for local project implementation each year.

Mr. Eastland mentioned that a copy of a letter from Ms. Tate with The Family Place, opposing the committee's funding recommendation, was placed at each Board member's location as a reference and stated that the letter was not originally included in the Board packet. Judge Hill then opened the floor for discussion. Councilmember Johnson inquired about the process of following up with Ms. Tate. In response, Ms. Schmidt stated that the Board has 14 days to notify all applicants of the approval decision and provide them with the reasoning behind the scoring.

Ms. Mendelsohn requested a breakdown of the items that The Family Place organization had raised. Ms. Schmidt explained that this was the first year in recent memory that allocation projections were not received before the grants were scored. She explained that Ms. Tate, a committee member, abstained from scoring her own organization's grant application. She further explained that the committee discussed how to best allocate the \$1 million budget cut in the General Victim Assistance category. The committee decided to make roughly a 10% cut across the board to increase the number of projects that could be funded in the region. During the scoring process, the amount for The Family Place application was reduced due to discrepancies in the budget. As a committee member, Ms. Tate received the draft funding list before it was released to all applicants.

Ms. Mendelsohn expressed concern about the reduced funding for The Family Place. She made a motion to restore their funding to \$2 million on a pro rata basis, by removing funding from any brand-new applicants and reducing other allocations. The motion was not seconded. Judge Hill clarified that the total recommended awards for the 5 new recipients exceeded \$380,000, so the second part of Ms. Mendelsohn's motion was unnecessary. Ms. Mendelsohn then amended her motion to simply not award funding to new applicants and instead allocate that money to the existing applicants. The amended motion was not seconded. Councilmember Hogg stated that he would not support changing the committee's recommended funding, saying they should have trust and faith in the committee's decisions and made a motion to recommend the funding as presented (2<sup>nd</sup> by Councilmember Johnson).

Item Title: Resolution Authorizing an Interlocal Agreement with Sourcewell for Cooperative Purchasing Activities

The North Central Texas Council of Governments (NCTCOG) cooperative purchasing program, known as TXShare, sponsors a regional purchasing program and facilitates the procurement process for its members, with the goal of increasing efficiencies in vendor management and reducing administrative burdens in public purchasing. In June 2022, the NCTCOG Executive Board authorized an Interlocal Agreement with Sourcewell, a public agency established by the authority of the State of Minnesota, for Cooperative Purchasing Activities, for a maximum three (3) year term, with a key aspect of expanding the TXShare program, leveraging national contracts with the goal of obtaining greater price savings for TXShare members and participating entities. The collaboration between TXShare and Sourcewell has been very successful, and staff recommends entering into a new Interlocal Agreement for a maximum five (5) year term.

Sourcewell has hundreds of national contracts available for use. NCTCOG staff have reviewed its standardized procurement process, contract terms, and compliance factors applicable to state and federal funding requirements and determined these contracts are suitable to promote through TXShare. NCTCOG's expertise will be made available to TXShare participants to assist in the evaluation of compliance with specific funding and other legal requirements.

Under the proposed agreement with Sourcewell, NCTCOG would receive twenty-five (25) percent of the administrative fee revenue received by Sourcewell for sales by TXShare members within the State of Texas with no additional cost to the participating entities.

A draft resolution authorizing an agreement with Sourcewell for cooperative purchasing activities, for a maximum five (5) year term, is attached for Executive Board consideration.

The North Central Texas Council of Governments (NCTCOG) is planning a regional, multi-discipline, multi-day full-scale exercise on a Complex Coordinated Terrorist Attack (CCTA) scenario designed to test regional resources and identify potential gaps and improvement areas. This exercise is being referred to as Metro X and will be held in October 2025. NCTCOG has hired a consultant, The Olson Group Ltd., to assist in carrying out Metro X. Scenarios include, but are not limited to, structural collapse, secondary devices, technical rescue, active shooter, VIP/VVIP vehicle ambush, mass casualty incident, explosion, and patient transport.

Staff is seeking Executive Board authorization to enter into agreements with entities that have agreed to serve as site hosts based on available facilities and scenario likelihood. Each party is responsible for its own costs and liability.

Item Title: Resolution Authorizing Contracts with Lone Star Pace and Texas Pace Authority for Regional Pace Program Administration Services

The North Central Texas Council of Governments Environment and Development Department, with cooperation and support from the Transportation Department, leads and supports a Regional Energy Management program funded by the State Energy Conservation Office (SECO). Since 2018, the Regional Energy Management Program has supported a regional effort to increase energy and water efficiency awareness and activities. Through this program, the Environment and Development Department is establishing a regional Property Assessed Clean Energy (PACE) program, the NCTCOG Regional PACE Program. A status report was provided to the NCTCOG Executive Board on August 25, 2022, on the establishment of a regional PACE program.

In June 2013, the Texas State Legislature passed the Property Assessed Clean Energy (PACE) Act, which enables local governments throughout the state to work with property owners and private sector lenders to finance energy efficiency and water conservation improvements through PACE programs. The purpose of PACE programs is to provide low-cost, long-term loans to owners of commercial, industrial, and multifamily properties to finance energy efficiency and water conservation retrofits. Property owners may apply for a voluntary property assessment with their relevant PACE program administrator and receive 100% financing for eligible improvements. The property assessment determines the eligibility of the proposed retrofits and a cost estimate for financing. A qualified lender may then issue a PACE loan to the property owner. The PACE administrator, through its contractor, continues to monitor both the status of the loan and the process of retrofitting.

Seventeen cities and nine counties in the North Central Texas region have their own PACE program, administered through a contract with one of two available third-party PACE contractors based in the state. The NCTCOG Regional PACE Program will provide the opportunity for local governments who do not already have a PACE program in their jurisdiction to sign an interlocal agreement with a regional PACE administrator and make PACE loans more accessible to property owners in their respective communities. This will particularly benefit smaller and more rural communities without the resources to establish their own PACE contracts. A regionally administered program will also further encourage standardization and reduce costs through a centralized application and assessment process.

Administration of the NCTCOG Regional PACE Program requires the selection of a qualified third-party PACE contractor, or Administrator. The Administrators will be responsible for the development and implementation of community outreach, coordination of the application and approval process, communication with lenders, and the development of reports on the impacts of the PACE program. NCTCOG will serve as the co-administrator of the NCTCOG Regional PACE Program.

As the co-administrator, NCTCOG will be responsible for the maintenance of an informational program webpage, conducting a final review of applications, and supporting outreach and education efforts. The Administrator(s) will establish uniform application and administration fees to be paid by participating Property Owners as compensation. The Administrator(s) will remit 25% of all application fees to NCTCOG, including any fees that are paid but do not result in a completed project, to cover NCTCOG program costs.

In order to ensure a competitive process and to continue providing projects desired by our member governments, NCTCOG initiated the procurement of a PACE contractor to administer the NCTCOG Regional PACE Program. NCTCOG issued RFSQ #2025-041 on February 13, 2025, to receive qualified responses from PACE contractors. NCTCOG received two (2) responses by the March 17, 2025, deadline.

The Evaluation Committee reviewed the proposals and found both firms to be equally qualified with nearidentical scores. The Evaluation Committee is therefore recommending a dual-award to Lone Star PACE and Texas PACE Authority to perform the required services. A draft resolution authorizing contracts to Lone Star PACE and Texas PACE Authority, for a five (5) year term follows.

- Item Title: Resolution Authorizing Agreements with Subrecipients of the 2024 Work Zone Data Exchange Call for Projects

In March 2022, the North Central Texas Council of Governments (NCTCOG), through its TXShare cooperative purchasing program, competitively procured vendors with expertise in 1) converting raw work zone data into the WZDx format, 2) establishing WZDx-compliant reporting systems, and 3) general WZDx services. On December 1, 2022, the Executive Board approved cooperative contracts with five vendors for these services. This project maps Executive Board approved contractors with interested local governments. Staff recommends authorizing agreements with seven local governments applicants to implement Work Zone Data Exchange projects utilizing NCTCOG's TXShare vendors to help in data sharing efforts in the region.

The Regional Transportation Council (RTC) has set aside \$2.5 million in federal funds to award local governments for the implementation of Work Zone Data Exchange (WZDx) services. A Call for Projects for Work Zone Data Exchange projects was opened September 16, 2024. The call closed on November 15, 2024. As part of the Call for Projects, applicants were required to use TXShare awarded vendors to streamline the implementation process, ensure compliance with federal grant requirements, and reduce risk to NCTCOG and its local government partners. A total of seven applications were received and reviewed, and on February 13, 2025, RTC approved project recommendations for the Work Zone Data Exchange Call for Projects.

Executive Board approval will be requested to enter into agreements with recommended subrecipients in its role as RTC's fiscal and fiduciary agent. Projects funded through the Work Zone Data Exchange Program will utilize up to \$2,427,804 of Surface Transportation Block Grant funds and 485,561 of Transportation Development Credits in lieu of local match.

A draft resolution authorizing execution of agreements with selected subrecipients is attached for Executive Board consideration. I will be available to answer any questions the Board may have on this item.

In July 2024, the Regional Transportation Council (RTC) announced the Blue-Green-Grey Application for New Ideas funding opportunity. This is the fourth time the RTC and Executive Board will be requested to support this program. Eligible projects were to be in the 12-county Metropolitan Planning Area and address innovative outcomes focused on three elements – Blue (water), Green (environment), and Grey (transportation infrastructure). Eligible applicants could include teams of individuals, private firms, and governmental agencies.

The RTC received a total of nine applications. The Selection Committee met in September 2024 to review and evaluate applications, and recommended awards for the following projects:

- Huitt-Zollars, Inc./City of Allen Inlet Filter Pilot Program
- Dallas Area Rapid Transit Vermiculture Food Waste Composting at Lawnview Station
- City of Frisco Median Bioswale Retrofit Parkwood Boulevard

The RTC approved awards for these projects on December 12, 2024. Executive Board approval will be requested to enter into agreements for the implementation of these projects in its role as RTC's fiscal and fiduciary agent, in an amount not to exceed \$75,000 with Huitt Zollars, Inc.; \$90,000 with Dallas Area Rapid Transit; and \$83,300 with the City of Frisco for a total not to exceed amount of \$248,300 RTC Local funds. No local match is required.

Item Title: Resolution Authorizing New Corsicana Workforce Center Lease

The North Central Texas Council of Governments (NCTCOG), in its capacity as the Administrative Entity and designated Grant Recipient/Fiscal Agent of the North Central Texas Workforce Development Board, currently operates a workforce center located at 720 N. Beaton Street in Corsicana, Texas, encompassing approximately 5,280 square feet of office space. The building is owned by the Texas Workforce Commission (TWC), which grants use of this space to NCTCOG through a building use contract agreement with no associated monthly rental cost. TWC has given notice of their intention to sell the property which they require to be vacated no later than December 30, 2025.

In coordination with NCTCOG's real estate broker, Avison Young, staff have identified a new Corsicana Workforce Center location and have coordinated terms as follows:

- Landlord: RBR Enterprizes
- Address: 3201 W. 7<sup>th</sup> Avenue
- Location: Close proximity to Navarro College (0.2 miles)
- Square footage: 2,305
- Lease term: Five (5) Years
- **Gross Rental Rate:** \$17.25 including base rent, taxes, insurance, common area maintenance, excluding tenant improvements, janitorial, and electric. Base rental rate is flat (no escalation).
- **Parking:** Abundant retail parking is available.
- **Tenant Improvements:** Landlord has agreed to fund and manage tenant improvements pursuant to specifications provided. The scope of work is continuing to be refined.

NCTCOG's real estate broker, Avison Young, performed a current market survey of other comparable properties (Exhibit A) and confirmed the proposed terms are within the market price for the surrounding area.

Staff have been analyzing regional data including population growth, job growth, unemployment rates, poverty rates, and child care access to better understand how, where, and when customers are choosing to engage with and access Workforce programs and services from a short, mid, and long-term perspective. The proximity to Navarro College and the reduced footprint of the proposed new location aligns with ongoing strategies to reimagine the Workforce Center of the future while remaining resilient to federal funding changes and constraints.

The Burleson Community Emergency Response Team (CERT) has played a vital role in strengthening emergency preparedness, volunteer training, and disaster response throughout the region. By expanding its outreach and training programs, the organization has created opportunities for residents to gain life-saving skills and actively contribute to community resilience. Over the past two years, Burleson CERT has demonstrated exceptional leadership, training, and community engagement, significantly strengthening disaster preparedness in Johnson/Tarrant County, Texas. Recognizing the need for sustainability, Burleson CERT transitioned into the Burleson CERT Association (BCA), a 501(c)(3) nonprofit organization, in 2024, enhancing its ability to secure funding, expand outreach, and improve training initiatives. This transformation has increased volunteer engagement, strengthened regional partnerships, and allowed for broader community education. Volunteers have contributed over 2,400 hours in the past two years, saving the City of Burleson an estimated \$79,489 in labor costs. Through structured leadership and innovative training, Burleson CERT has positioned itself as a leading program in emergency response and preparedness.

Training remains central to Burleson CERTs mission, with 50 new members completing Basic CERT courses in the past two years. Monthly training sessions have covered first aid, triage, fire safety, and emergency communications, ensuring volunteers are fully prepared to respond to crises. The program has also played a key role in regional disaster exercises, including the 2023 joint exercise with Fort Worth CERT and the hosted the 2024 "Disaster Day" full-scale simulation with 30 volunteers from Burleson, Fort Worth, and Hood County CERT. These hands-on exercises have improved interagency coordination and real-world emergency response capabilities. Additionally, Burleson CERT has prioritized inclusive preparedness efforts by partnering with the Center for Autism Spectrum Disorder (ASD), ensuring that individuals with autism and special needs are included in disaster planning. CERT members have received specialized training from guest speakers and participated in disaster simulations incorporating special needs scenarios, preparing them to provide compassionate and effective emergency assistance.

Because of their dedication, innovation, and tireless service, Burleson CERT was selected as the recipient of the FEMA Region 6 Community Preparedness Award for the Whole Community—an incredible honor that spans five states and recognizes programs that lead the way in community-focused emergency preparedness. Burleson CERT is more than a team of volunteers—it is a shining example of what grassroots resilience looks like. Their work continues to build trust, capability, and strength in not just the City of Burleson but the region.

- Item Title: Resolution Authorizing Agreement with the City of Ennis for the Business 287/Ennis Avenue Grade Separation Funding Partnership

On June 13, 2024, and January 23, 2025, the Regional Transportation Council (RTC) approved a total of \$39,800,000 in federal, State, and/or local funds for the Business 287/Ennis Avenue Grade Separation project. RTC approval included advancing funds with the condition that the City of Ennis would contribute \$5,000,000 plus interest to the North Central Texas Council of Governments (NCTCOG) as RTC's fiscal agent.

The City contribution reflects the economic development impact of the project and desire to help reimburse the RTC for cost overruns. Ellis County also participates in the TIRZ and is committing a portion of its TIRZ revenues. The Texas Department of Transportation will construct the project, which is anticipated to be complete in 2029.

Staff has been working with City staff on the proposed payment terms. The Ennis City Commission has been briefed as well as the TIRZ Board. It is staff's understanding that the City and TIRZ Board support the following payment terms, subject to final action on the TIRZ Project and Finance Plan. These terms are consistent with previous RTC advances related to transportation projects with economic development components.

The proposed terms for the City contribution on the loan are as follows:

City Contribution Amount: \$5,000,000.00 Number of Payments: 15 Payment Frequency: Annual Interest Rate: 2.4% Annual Payment (Payments #1-14): \$350,000 Last Annual Payment (Payment #15): \$1,291,389.95 First Payment: November 30, 2029

The City is only committing TIRZ revenues as the source of payment for the loan. If for any reason the City is unable to make an annual payment, any unpaid amounts are added to the next scheduled annual payment, plus interest. If any unpaid amounts remain unpaid after the last scheduled annual payment, the City shall continue to make payments until the Contribution amount is fully paid through the life of the TIRZ (December 31, 2045).

Executive Board's approval will be requested to authorize an agreement between NCTCOG as the RTC's fiscal and fiduciary agent and the City of Ennis for NCTCOG to receive \$5,000,000 plus interest from the City of Ennis. Attached are architectural renderings of the existing opportunity.

A draft resolution authorizing an interlocal agreement between NCTCOG and the City of Ennis for the Business 287/Ennis Avenue Grade Separation project funding partnership with terms in substantial conformity with the above is attached for Executive Board consideration. The North Central Texas Council of Governments (NCTCOG), in its capacity as Administrative Entity and designated Grant Recipient/Fiscal Agent of the North Central Texas Workforce Development Board, issued a Management and Operations of the Workforce Development System Request for Proposals (RFP) on February 6, 2025, soliciting responses from qualified organizations. The RFP closed March 13, 2025. Following evaluation, Career Team, LLC is recommended as the Workforce Development System Subrecipient.

In order to provide for a seamless implementation, staff is proposing a transition period beginning on or around June 1, 2025 through September 30, 2025, with the initial one (1) year contract term to begin October 1, 2025 through September 30, 2026. The contract will include an option to renew for up to four (4) additional one-year terms, for a total contract amount not to exceed \$115 million.

A draft resolution authorizing a contract with Career Team, LLC, for a maximum sixty-four (64) month term and in an amount not to exceed \$115 million, is attached for Executive Board consideration. The North Central Texas Workforce Development Board recommended this award at its May 6, 2025 meeting.

Item Title: Status Report - Presentation of 2025 Current Population Estimates

The North Central Texas Council of Governments (NCTCOG) has completed the 2025 Current Population Estimates for the North Central Texas region. This includes estimated population totals for all cities over 1,000 in population, each county, the twelve-county metropolitan planning area, and the region. Revised and updated estimates for 2024 are also provided.

Local governments supplied input as part of the estimation process and were given an opportunity to review draft numbers prior to finalization. NCTCOG's population estimates are often cited and are recognized for their coverage, timeliness, and uniqueness.

Brian Lister, Senior Research Data Analyst, will be available at the Executive Board meeting to present the 2025 Current Population Estimates and to review the highlights of the region's recent population growth.



### Summary

Regional population grew by 234,125 last year. Collin County added almost 76,000 new residents, while Dallas County grew by more than 45,000 new residents, followed by Tarrant County (35,746) and Denton County (31,635). The region now has a population of 8,718,500, a growth of more than 886,000 since the 2020 Census. Fort Worth added 32,191 new residents, followed by Dallas (29,510), Celina (15,980), McKinney (11,310), and Princeton (9,838). Cities with populations of 1,000 or more are reported individually in this report.

#### 2025 Population Estimates Methodology

NCTCOG uses the housing unit method for estimating current year population:

Estimated household population = estimated units \* estimated occupancy rate \* estimated persons per occupied unit

The calculation is performed for each unit type (single family, multi-family, other). The results are summed along with an estimate of group quarters population to arrive at a total population estimate. Every year, cities are asked to provide information about changes in housing stock and population in group quarters housing. Cities are also given the opportunity to review figures prior to release. The 2024 population estimates for some cities have been revised. The estimates included herein supersed any prior estimates.

Copper Canyon, Runaway Bay, and Wolfe City did not participate in the survey.

Unincorporated data were not available for the following counties: Denton, Erath, Hood, Hunt, Navarro, Palo Pinto, Parker, Wise.

Various totals and percentages provided throughout this report are calculated on rounded figures and therefore might not match precise sums and percentages calculated on unrounded figures.
