Texas Stream Team is a statewide water quality citizen science program that has been training individuals to test and report water quality in their own communities since 1991 to fill in gaps in routine professional monitoring. Ally Schlandt, Program and Outreach Specialist, will provide an overview of the program and its history, and how individuals, organizations, and cities can get involved.

The program offers training and education on Texas water quality testing for citizens. Trainings include basic classes in Standard Core Water Quality Citizen Scientist Training and further classes in other subjects.  - The Wastewater and Treatment Education Roundtable will meet on October 20, 2022 at 10:00 a.m. Location to be determined.




