Public Education Task Force

- The <u>campaign resources</u> for the 2024 March is Texas SmartScape Month have been shared with members of the PETF via email. These resources include the sample longform newsletter and shorter blurb. The corresponding graph for 2024 is delayed due to a staffing vacancy on the NCTCOG communications team.
- o The 2024 North Texas Community Cleanup Challenge (NTCCC) will take place from March 1st, 2024, through May 31st, 2024. Entities who wish to participate in the NTCCC or the optional Mayors' Challenge have until April 15th to join the challenge. The reporting deadline for activities which took place during the challenge timeframe is June 30, 2024. All trash reports for the challenge are submitted through the <u>Texas Litter Database</u> using the external ID "CCC24". Learn more about the NTCCC at the <u>program information page</u>. To date, the communities of Carrollton, Dallas, and Mansfield have all signed on.
- The FY24 Special Project of continuing work on a series of educational videos is on hold while staff look for additional options to facilitate the video production. Recent quotes were cost prohibitive. Any significant updates prior to the next meeting will be shared electronically.
- PETF Activity Reports have been completed and shared with the members for their reporting periods.

Pollution Prevention Roundtable

- o Drafts of the template reminder messages along with the corresponding visual posters were shared. These drafts will be shared with members of the Pollution Prevention Roundtable at their next meeting for finalization.
- o A BMP Show and Tell event to serve as an educational event for the group is planned with details to be announced later after confirmation of all speakers.

• Illicit Discharge Detection & Elimination Roundtable

- o The IDDE group has completed a Manure Management BMP brochure as well as a Construction General Permit 2023 Update Infographic.
- o Members will discuss training workshops for 2024 at their next meeting.

Stormwater Monitoring Program

- The initial draft of the proposal for the Fifth Permit Term is being reviewed by TCEQ and it will be a minimum of 60 days before any feedback is received.
- TCEQ confirmed compliance within the Phase I permits following the Regional Wet Weather Characterization Program (RWWCP), however, it is too early to confirm the official start date of the new program term.

Lewisville: Finally received approval on last Permit. Streets installed trash collection devices that were vandalized. Stormwater software vendor is going out of business so looking for new vendor.

DART: Finalizing the Annual Report and looking forward to the next permit. Will have a position opening soon.

Waxahachie: Wrapping up a study on Waxahachie Creek. About to submit the Annual Report. Will update all creeks that were just studied.

Burleson: The 2019 Permit was approved. Have taken on promoting Bluebonnet RCND. Willing to help all counties that are served. Will have small community improvement grants opening soon - March 21st - \$1000 match fund. Have been dealing with a beaver issue.

DFW Airport: CIP updating sensors and aerators.

Weatherford: Working with Jai-W on the TSI program.

Denton: In 2017 were working with Army Corp. Project is picking back up and proceeding very quickly to mitigate flooding.

Grand Prairie: Working on MS4 annual report. For the WPP with Joe Pool Lake, just had some grants approved.


Cedar Hill: Du Vu has left the City of Cedar Hill so please reach out to Lauren Betz.


