1. Welcome and Introductions.

2. **Meeting Summary.** The <u>July 24, 2025 meeting summary</u> is available online for your review.

The July 24, 2025 meeting summary was approved.

3. **Educational Item Show and Tell.** Attendees are encouraged to bring booth games, outreach giveaways, and other related wastewater educational materials to the meeting to share. Attendees will discuss best practices for engaging the public regarding wastewater issues at outreach events.

Attendees shared an array of innovative and interactive booth games, ranging from sorting games to "potty tosses," as well as additional outreach efforts such as flyers, newsletters, and more. Thank you to all that participated in the show and tell!

4. **FY2026 Work Program Update.** NCTCOG will share an update on the FY2026 Work Program, invoicing process, and anticipated tasks. NCTCOG will also provide a recap of FY2025 achievements and request feedback from attendees on deferred funds expenditures.

NCTCOG shared an update on the invoice process for the FY2026 Work Program and anticipates that invoices will be distributed in late October or early November 2025. NCTCOG informed attendees that the final FY2025 Work Program Summary will be posted online in November 2025. Attendees discussed potential avenues for spending deferred funds from past Work Programs in the future, including translations of existing educational explainer videos into Vietnamese and purchase of branded giveaway materials, such as FOG bags, funnels, scrapers, and more, that could easily be paired with an educational flyer explaining program benefits.

5. **Holiday Grease Roundup Update.** NCTCOG will provide an update on the 2025 Holiday Grease Roundup.

NCTCOG provided an update on the 2025 Holiday Grease Roundup, which is scheduled for November 1, 2025 through January 31, 2026. 48 partners have committed for the 2025 event and marketing materials are available on the WATER webpage. Attendees also discussed next steps for seeking additional grease/cooking oil collection vendors for the 2026 Holiday Grease Roundup.

6. **Defend Your Drains North Texas Promotional Activities Discussion.** NCTCOG will provide an update on activities and analytics from the Defend Your Drains website and social media activities.

NCTCOG provided a brief update on social media and website traffic. Attendees discussed the potential need for a panel or discussion opportunity to hear how other entities communicate with their Communications Department or Public Information Officer (PIO) to get wastewater information posted on official city channels, best practices for communications and meeting ADA requirements, and more.

7. **General Updates.** NCTCOG will provide general updates on relevant programs and events.

The Houston-Galveston Area Council and other partners launched the Texas Water Careers website (https://texaswatercareers.com/) that has the mission to inspire, train, and mentor the next generation of water and wastewater professions, change the narrative around utility careers, highlight the value of water and wastewater roles, and create real pathways for success in the industry.

9. **Schedule for the Next WATER Meeting.** The next WATER meeting is tentatively scheduled for January 15, 2026, location to be determined.
