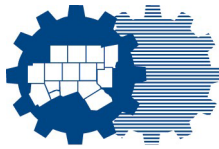

[The RCCC discussed the nominations received for the singular Public Sector Vacancy. Brett King, City of Carrollton, motioned for Zac Loiselle, City of Pilot Point, to be accepted as a member of the RCCC. The motion was seconded by Wayne Snell, City of Irving. The motion passed unanimously.](#)

[The RCCC discussed the Chair and Vice-Chair positions, which are reelected each year. Bahman Yazdani, Texas A&M Energy, nominated David Kerr, City of Melissa, and Selso Mata, City of Plano, to remain the respective Chair and Vice-Chair for the RCCC. This motion was seconded by Brett King, City of Carrollton. The motion passed unanimously.](#)

4. **Regional Codes Work Program Discussion and Vote.** NCTCOG will update the RCCC on the recommendations of the Regional Codes Work Program Task Force on the Work Program, funding levels, and other activities. The committee will vote on the changes to the Work Program.

[NCTCOG presented an overview of the updated Work Program, including major changes, suggestions, and plans for FY2025. The Work Program Task Force recommended removing items that are duplicated by](#)

external building association groups, such as BMP education, videos, etc. as well as the Standardized Plan Review Process. The Task Force also suggested that the Code Amendments be restricted to those that are cost-sharing members or those that pay for them, similar to how the Public Works Construction Standards and Work Program is set up. The RCCC requested for additional time to review the revised Work Program before voting. NCTCOG will provide RCCC members with additional time to provide feedback on the Work Program before requesting a vote.

DISCUSSION ITEMS

- 5. Advisory Boards and Regional Recommended Code Amendments Update.** NCTCOG and Advisory Board Chairs will update the RCCC on the current status of the FY2024 Advisory Boards Review meetings.

Building & Residential Advisory Board: The Building & Residential Advisory Board met in June regarding residential codes and expect to have their associated codes completed in Fall 2024.

Energy & Green Advisory Board: The Energy & Green Advisory Board is still waiting on the code book to be released to begin working on their amendments.

Fire Advisory Board: The Fire Advisory Board met on July 23, 2024 in Flower Mound, and they are approximately halfway through their associated codes. FAB expects their code review process to be finished in Fall 2024.

Plumbing & Mechanical Advisory Board: The Plumbing & Mechanical Advisory Board is currently working on their amendments. Spa and Pool codes are all that is left to review. They are projected to be completed by the end of August.

- 6. Annual Code Adoption Survey Results.** NCTCOG will present the results of the Annual Code Adoption Survey and Story Map.

NCTCOG presented the results of the Annual Code Adoption Survey and Story Map. Next year, NCTCOG plans to share the results of the annual survey as well as a 10-year overview of past survey results.

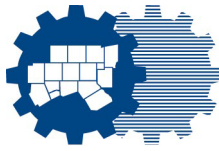

This meeting will likely be rescheduled to accommodate the completion of regional code amendments.

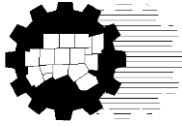

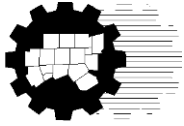
