Local Bond Program Partnerships

The goal of the effort is to leverage bond funds for projects of strategic importance to local governments and the region. Staff will present projects recommended for federal mobility and air quality funds through the Local Bond Program partnerships effort.

Call for Projects Recommendations: Federal Transit Administration **Funding Programs**

NCTCOG issued a Call for Projects to competitively award Federal Transit Administration funding from two programs that support transportation services for seniors, persons with disabilities and low-income individuals. Approximately \$6.5 million in funding was available to award in the Dallas-Fort Worth-Arlington and Denton-Lewisville Urbanized areas. Staff will present recommendations to award ten projects the available federal funding.

Electric Vehicles in North Texas Update

Electric vehicle sales are on the rise due to a number of factors, including the renewed EV rebate program, new makes and models, and educational events. Staff will highlight elements of this year's National Drive Electric Week celebration as well as other information about regional EV trends and resources. MPO and Local Governments Training:

Strava Crowdsourced Bicycle and Pedestrian Demand Data

TxDOT's Public Transportation Division (PTN) – Statewide Bicycle and Pedestrian Program is excited to bring <u>Strava Metro</u>'s crowd-sourced bicycle and pedestrian data to its local government partners! TxDOT-PTN recently purchased two years of Strava bicycle and pedestrian data and will be sharing this data with local government entities (including MPOs, cities, counties, management districts, etc.) at no cost.

Regional and Local Partners Training Details

Strava staff will provide 3-hour informational training sessions geared toward local government and MPO use of Strava data that will be made available through TxDOT. Training will focus on how to access and use Strava data for planning and project development, including correlating Strava data with bicycle count data.
