1. Welcome and Introductions.

David Kerr, City of Melissa and Chair of the RCCC, welcomed all meeting attendees.

2. Summary of the July 16, 2019 Meeting.

The meeting summary was approved unanimously.

3. Advisory Board Membership and By-laws Amendments.

Staff introduced new language to address comments received at the Committee's previous meeting. The Committee approved the new language as written in the draft documents supplied at the meeting.

4. Electronic Plan Submittal Subcommittee Activities.

Christine Hadley introduced the draft Best Practices document and accompanying tables, which would be used for electronic plan submittals. The discussion focused on matching the AIA numbering system, and how to promote this new numbering system as a Best Practice in the region. The RCCC Chair recommended that the Subcommittee bring back language regarding the AIA and the NCTCOG recommending this new numbering system. The subcommittee will meet again to discuss the language, and any member of the RCCC who is an architect is encouraged to attend.

5. Regional Codes Coordinating Committee FY2020 New Members.

New members were welcomed. George Wallace has stepped down due to unexpected family issues. Staff will send out membership applications for the RCCC to review and vote at their next meeting. The same application form is used for the Advisory Boards.

6. Regional Codes Work Program Discussion.

Staff presented current cost share commitments. The Committee discussed becoming an ICC member and preferred provider. The Committee voted to become an ICC member with on-site preferred provider status. The Committee wants more training opportunities available, and for Staff to look into co-sponsoring local events, such as the Swim and Spa Code training event scheduled for February 2020.

7. Code Adoption Outreach.

Staff played the draft Code Adoption video. After viewing, the Committee made a list of items to address:
