# **DISCUSSION/ACTION ITEMS**

5. **2024 March is Texas SmartScape Month.** NCTCOG will lead a discussion on campaign slogan ideas for the 2024 March is Texas SmartScape Month campaign.

NCTCOG staff opened up a discussion for March is Texas SmartScape Month slogans for 2024. Early selection of a slogan allows the Communications team to capture images to support the slogan throughout the growing season. No slogan suggestions were received during the meeting. Feedback was given to include pollinators, particularly Monarchs. Staff will send out a survey to collect suggestions and follow up with another survey for voting in April.

6. **PETF FY22/23 Work Program Discussion.** NCTCOG will provide an update on the Fiscal Year 22/23 Work Program Special Project and gather feedback on progress.

NCTCOG staff presented the group with an updated storyboard and script for the video *Why Stormwater is Important* and opened up a discussion to receive feedback. Updates to the *Why Stormwater is Important* script included adding an analogy comparing watersheds to bathtubs.

Comments on the *Video Vocabulary List* included the feedback that some words may be too high level for K-2, but could still be useful for teacher background, allowing them to decide what words to use with students. Suggestion to use word "play" instead of "recreation" and "soaking in the ground" instead of "infiltration".

Next staff led the group in a discussion on the video *What to Look for Around Town* to receive input on a draft of the storyboard and work on adding additional details. Comments received included:

- Agreeing with the use of the character Rain Drop narrating the video to add continuity across the videos and setting the video at an apartments complex.
- Incorporate all suggested scenarios kids will encounter into the script (landscaping crew, oil leaking from vehicle being repaired, spill by homeowner, pet waste).
- Changing the mechanic scene to someone just working on their car at home as a more likely scenario to be encountered.
- Changing a spill by a homeowner to soap running down street from vehicle being washed in a driveway.
- Adding visuals showing dumpster lids open at apartments and trash cans with lids open on the walk.
- Show litter (packaging, wrappers, single-use items) on ground as floatable issue and a primary focus throughout.
- Work in used cooking oil being dumped down a stormdrain.
- Have pauses in the video as the characters are walking where students watching can stop and try to point out the stormwater issues they see, an "I spy" moment, to incorporate everything.
- Have Rain Drop pop in and make kid friendly suggestions to teach new behaviors.
- To address how kids and adults should respond, keep the focus of encounters on what kids can do personally and how they can educate their families but NOT confront the people who are "messing up".
- For landscape crew encounter, can talk about mulching or composting leaves but more appropriate for older ages.
- For litter encounter, talk about properly throwing away trash and participating in litter cleanup events. Even if you didn't make the mess you can still be part of the solution.
- Rain Drop can remind kids to bring poop bags with them when taking their dog for a walk.
- Be mindful that many kids are taught to NOT to engage the authorities, for various reasons. The message is to do the right thing at a personal level.

- Have Rain Drop mention that most cities have events and information to prevent litter and mention who to call if they see something. Keep the suggestions on reporting generic such as call the city you live in to report any issues.
- Consider incorporating the idea to check with a local library brings focus to learning/education as a solution vs. reporting.
- For explaining the concept of a storm drain, consider simplifying description as a structure that carries rainwater away from a street, parking lot, etc. Perhaps even using pipes instead of structure as it relates to what kids have likely seen.

7. Other Stormwater and NCTCOG Program Updates. NCTCOG will share recent and upcoming activities of the Illicit Discharge Detection and Elimination, Stormwater Monitoring, Total Maximum Daily Load, Wastewater and Treatment Education Roundtable, and Trash Free Waters programs. NCTCOG will also provide an overview of upcoming conferences, events, news, and resources of relevance to the group.

**Trash Free Waters:** Save-the-Date for an upcoming webinar on February 28, 2023. <u>Registration</u> is now available. Project staff will be purchasing materials for cities interested in piloting the materials in the Recreational Litter Cleanup as well as the Restaurant Toolkit. #### 8. Roundtable. Members will share what is happening in their communities.

**Carrollton:** Andrea McClure had no updates share but introduced herself to the committee as a new Carrollton staff member.

Grapevine: Hosting a Household Hazardous Waste event on March 25th.

**Mansfield:** Hosting a huge field trip with 180 Environmental Science High School students coming to learn about stormwater protection. Trinity River Authority and Tarrant Regional Water District, along with city staff, will be teaching. Will also be hosting a plogging event on January 28<sup>th</sup>.

**Burleson:** Hosting a Household Hazardous Waste event. Would like to know if anyone has been able to get tree saplings for Arbor Day, through grants or otherwise.

**Southlake:** Hosting a STEM Night event to make native and adaptive seed bundles with children. Will be talking about the stormwater quality and water conservation perks of native plants. Next month will be presenting on their Sustainability Initiative to the City Council, including Christmas Tree/Leaf/Grease recycling.

**Coppell:** City used to have a tour of homes for Texas SmartScape which had a lot of interest and participation from the community. Hoping to hold another event as a self-guided tour at the parks and to get some videos. Trying to use the event to connect the dots to water quality. NCTCOG staff mentioned Dallas and Plano usually do an annual SmartScape/Waterwise tour and may be a resource to reach out to for advice.

North Richland Hills: Have a stormwater audit next week with TCEQ.


**TRWD:** Will be at Kids Gone Wild exhibit at the Fort Worth Stock Show and Rodeo this Sunday. Have had an oddly large number of winter events going on this year; seeing a steady stream of demand for trailers and already lining up Spring events. Reminded group that to use stream trailers there is a facilitator training and rental agreement that are necessary beforehand. There is probably not enough time to hold a facilitator training ahead of Spring events at this point but something to keep in mind for the rest of the year. The entire watershed protection team will be at Urban Riparian Symposium in San Marcos in February.
