1. Welcome and Introductions.

ACTION ITEM

2. Meeting Summary. The January 12, 2022, meeting summary will be presented for approval.

Billy George, North Texas Municipal Water District, made a motion to approve the January 12, 2022 meeting summary, and Grace Darling, Arlington Conservation Council, seconded the motion. The motion passed unanimously.

PRESENTATIONS

3. The Impact of U.S. EPA's Lead and Copper Rule Revisions on Water Utilities. Dan Crowley, Director – Governmental Relations, Regional and Federal Affairs, San Antonio Water System, on behalf of the American Water Works Association's Water Utility Council, will present and provide insights.

Mr. Crowley noted that water service line inventories are due by October 16, 2024, and U.S. EPA is currently developing a more stringent rulemaking for the LCRR. He suggested affected parties start planning now.

4. Filling the Water Workforce Pipeline: WEAT (Water Environment Association of Texas) Operator Apprenticeship Program. Julie Nahrgang, Executive Director, WEAT, and Dylan Christenson, Co-Chair of WEAT's Workforce Development Committee, will present on this program. With over 35% of the water workforce eligible to retire in the next five years, attracting, training, and retaining skilled water workers is one of the most pressing problems facing the water sector. WEAT's Department of Labor Apprenticeship program brings together state agencies, federal funding, educational institutions, water workforce employers, and passionate volunteers and staff to facilitate a water workforce development solution: the Department of Labor Water/Wastewater Apprenticeship Program.

Ms. Nahrgang and Mr. Christenson shared their journey in creating this apprenticeship program, which seeks to attract, train, and retain a skilled workforce for the water sector, and encouraged

ways for those in the water workforce, which includes a greater number of retirees than in other fields, to share journeys and information about their jobs with the younger generation. The WEAT Operator Apprenticeship Program is registered with the U.S. Department of Labor. If you are interested in becoming an employer partner, contact WEAT.

DISCUSSION

5. 2022 Water Resources Questionnaire Results. NCTCOG will present the results of the annual questionnaire, which closed on March 11, 2022.

NCTCOG presented the results from the questionnaire, which was distributed to water resource professionals in the region from February - March 2022. The results show that about 75% of respondents are engaged in outreach on water resources topics. Most respondents use social media or utility bill inserts to reach their target audiences outside of in-person events. Out of eleven water resources topics, the one that rated highest for level of concern among respondents was litter in waterways, which was fourth place on last year's questionnaire. And, respondents showed agreement on the need for more public education about the impacts of nonpoint sources on water quality.

6. 2022 Update to the North Central Texas Water Quality Management Plan. NCTCOG will provide on update on the progress of this deliverable.

The draft of the 2022 Water Quality Management Plan (WQMP) is still on track and will be available for a 30-day public review in June 2022.




