DISCUSSION ITEM

6. **iSWM 5-Year Outreach and Implementation Strategy.** Halff Associates will present an update on iSWM's Outreach and Implementation Strategy. (Sydni Ligons)

Sydni Ligons with NCTCOG and partners at Halff Associates discussed new strategies and goals of the iSWM Subcommittee for the 5 Year Outreach and Implementation Strategy they are developing. The goals of iSWM are to increase awareness and adoption of iSWM program, certification, and iSWM principals; identify key levels of city management and regional organizations that need to be engaged and with what level of frequency; and refine the vision and messaging plan to be implemented over the next 5 years. The purpose of iSWM is to meet construction and post-construction obligations under state stormwater permits, and achieve water quality, streambank protection and flood mitigation goals by providing guidance for development. Below are questions that the presenters asked the Council and the Council's response and discussion based on them.

- 1. How Could the iSWM program be improved to better meet these goals in the future?
 - There was no response from the Council.
- 2. What important outcomes will indicate the success of the iSWM program to the PWC?
 - The Council wants iSWM to work with developers more. The cities have some incentives for developers, like Stormwater Utility fees, but without savings through fees or increased development acreage most developers will not include iSWM practices. iSWM should also focus on the long-term benefits to developers and property owners when they discuss the concern about higher initial construction cost.
 - The Council also wants to see more participation in the iSWM program.
- 3. Who could be the most impactful ambassador of the iSWM program: citizens, city staff, elected officials, private sector companies or individuals, organizations, or other?
 - The Council responded that city staff and elected officials are the most impactful ambassadors of the program.
- 4. Consensus: are we headed in the right direction with the strategies we discussed?
 The Council voted 13-1 that they are heading in the right direction.
- 5. Is there anything iSWM could be doing or roles iSWM could pivot to fill that have not been addressed yet?
 - The Council had no feedback on this item but if anyone thinks of something they can email Sydni at <u>SLigons@nctcog.org</u>.

7. **FY 2020 Public Works Work Program Update**. NCTCOG staff will update the Council on recent Public Works efforts and Subcommittee activities. (Olivia Kale)

There are 58 communities that cost-shared into the Regional Public Works Program this year. The Public Works Council had set a goal of going from an average of 46 communities to 70 communities participating, so this is a great step forward. Money that is not spent this fiscal year will be put into a deferred account for future use.

• Sustainable Public Rights of Way. Subcommittee Chair will update the Council on the activities of the SPROW Subcommittee. (Robert Woodbury)

The Subcommittee met on Aug 18th and discussed the chapter Landscape Planning and Vegetation Maintenance for the SPROW BMP Guidebook. The subcommittee is creating a tree matrix that will list trees and their attributes like crown spread, maximum tree height, average life span, etc. They will also create a similar list for shrubs and other vegetation. Their next meeting is Oct 20th at 1:30pm on Microsoft Teams.

 integrated Stormwater Management (iSWM) Activities. Subcommittee Chair will present an update of iSWM program activities. (Ranjan Muttiah)

The Subcommittee last met on April 27th and is now beginning work on Task Order 4 which started May 1, 2020, and will go through April 30, 2021. They are developing cover pages for each primary water quality stormwater control. Additionally, they will research and create guidance on developing a regional detention program, re-evaluate the 85th Percentile (1.5") Rainfall Requirements, and provide details and specifications for water quality BMPs. The highest priority is the 5-Year Outreach and Implementation Strategy which was discussed earlier in the meeting. The next iSWM meeting is October 7, 2020 at 1:30pm through Microsoft Teams.

• Cooperative Technical Partnership Program and the Community Rating System Users Group. NCTCOG staff will provide an update on FEMA's Cooperative Technical Partner (CTP) Program activities and the Floodplain Administrators/Community Rating System Users Group. (Mia Brown)

For FY17 CTP projects, the flood resilience meetings are complete for Town Creek and Stream CF-5. The Richland Chambers Watershed Post-Discovery Webinar was also held on April 2nd. The recording and Draft Discovery Report can be found here: https://www.nctcog.org/envir/watershed-management/cooperating -technical-partners/discovery. These projects will close out in the fall.

The Flood Risk Identification Project on Marys Creek in Parker County is 70% complete for the FY18 CTP project. The flood risk review virtual meeting will be scheduled late this summer.

For FY19 CTP projects, the Harriet Creek (Denton County, 7 mile) and Waxahachie Creek (Ellis County, Midlothian, and Waxahachie; 19 miles) flood risk identification projects kicked off in April and are ongoing.

For FY20 CTP projects, NCTCOG received awards for flood risk identification on Catherine Branch (Denton County) and communications and outreach to the northern/western area of the region for integration of transportation and stormwater planning.

The Annual Combined CRS Users Group and Elected Officials Floodplain Seminar was held Tuesday, July 30th from 1:00pm-4:00pm with speakers from Texas Water Development Board.
