




Texas Annual Funding Comparison




Texas Grants by Funding Source 2022




NCTCOG Region vs. Non-Regional Funding 2022




2022 DFW Region **Annual Funding Comparison**


Phase 1

TCEQ Regional Nonattainment Reclassification

The Texas Commission on Environmental Quality (**TCEQ**) is hosting a call to discuss the proposed changes to the reclassification of our region due to the inability to meet federal attainment, for the pollution ozone, and the possible emission reduction measures that may result. Those working in the transportation sector who have input on what they are doing, or can do, to help reduce emissions in their sector may attend in order to be able to provide input to TCEQ on ideas such as: what strategies could be needed, an implementation process, barriers to strategies, and confounding factors.
