1. Welcome and Introductions. The subcommittee reviewed the summary from October 8, 2019 and approved it.

## **DISCUSSION ITEMS**

2. **SPROW BMP Guidelines Document Development Process.** Group will discuss development and structure of a BMP Guidelines document.

NCTCOG staff presented the results from the SPROW survey on topic prioritization. The top five topics in order are: Landscape Planning and Vegetation Management, Utilities, Complete Streets Planning, Green Infrastructure and Low Impact Development, and ROW Planning, Administration, and Policy. The subcommittee wants these top five topics to be their topics at the Public Works Roundup.

NCTCOG staff brought the Houston Scenic Best Management Practices book for the subcommittee to review. The group liked how simple it was but wants to provide more information to help communities make decisions. They discussed including a pros and cons list, cost where applicable, and matrices. They will not be writing specifications so there won't be CAD sketches or plans.

NCTCOG recommended that the subcommittee break into one working group and focus on one topic at a time. The subcommittee agreed to start with the first topic and make their way down the list. Robert would like to touch on each of the top 5 topics before the Public Works Roundup. Instead of splitting up into smaller groups the subcommittee will tackle each topic at the subcommittee meetings. NCTCOG will invite other organizations and experts in each topic to the meetings.

The subcommittee discussed how they will break down the first topic of landscape planning and vegetation maintenance. They will have subtopics, species list, and a pros and cons list. Some of the topics they discussed reviewing at the next meeting include where to plant trees, stormwater management, redevelopment considerations, landscape easements, ADA ramps, utility lines avoidance (overhead and underground utilities), and irrigation.


