OTHER BUSINESS AND ROUNDTABLE DISCUSSION

6. **Discussion on Detention in Grand Prairie.**

Ryan Harrell with the City of Grand Prairie is updating their Drainage Design Manual and provided an item of discussion for the subcommittee:

They are having to buy out homes along creeks that have experienced erosion. There is potential of upstream development that did not provide detention. They are trying to be more proactive in looking at detention. They cited a fee in lieu of program from the City of San Antonio and wanted to see if any other city uses something similar.

The City of Irving mentioned that this sounds similar to impact fees, which usually relate to extending storm lines and planned development. Also sounds similar to wetland mitigation.

The City of Mansfield mentioned that in the early 2000s the city did master plans on FEMA level water ways which included using series of detention ponds as a strategy. They are not aware of any municipalities in our region that use a fee in lieu of. The mentioned that as adjacent cities, they would be open to a visit with the engineering staff.

Ryan with the City of Grand Prairie mentioned that timing studies have resulted in erosion downstream as the storms without detention has lead to additional problems.

The City of Irving mentioned that they may need to consider extended dry detention and provided some examples of what to be aware of.

Michelle Troy with Quiddity Engineering offered to reach out to Grand Prairie to share expertise on whether fee in lieu of makes sense.

8. Future Agenda Items and Roundtable Discussion.

City of Mansfield has worked with Walter P. Moore to update Drainage Design Criteria Manual to fit new format of iSWM Manual. They have gone through each of the individual modules of iSWM, and will be submitting for iSWM certification upon completion. They have also received notification that their SWMP has been approved.

City of Irving – Stormwater department has recently taken over pesticide work from parks department. They have digitized corridors that are sprayed, reducing the amount sprayed by 90%, saving the city money and should help reduce erosion.

Edith Marvin, NCTCOG – Requested any feedback on use of NOAA Atlas 14.

City of Mansfield – Local criteria changes included an intensity table based on a centroid of the city. This was done to limit issues with development engineers on where to get their data.

Future Agenda items include:

Roadmap of how a community could become more involved in iSWM, including how to implement and what obstacles may be present.
