



### **Public Works Council**

1. **Welcome and Introductions**. The Public Works Council (PWC) Chair will welcome everyone to the meeting.

## ACTION/PRESENTATION/DISCUSSION ITEMS

2. **Meeting Summary**. The May 19, 2016 meeting summary is available online for review. Approval will be sought at the meeting.

The meeting summary was approved with no comments.

3. Electric Car Presentation. NCTCOG's Transportation Department will present information on electric car programs to the PWC. (Rachel Linnewiel)

Rachel Linnewiel (NCTCOG staff) presented information on electric car variations, service equipment options/charging stations, ownership variations, installation requirements, and battery efficiency and maintenance. The Public Works Council discussed charging station types and asked questions regarding NCTCOG's onsite charging stations. The City of Cedar Hill spoke about electric vehicles that were purchased for their city.

It was also announced that there will be a National Drive Electric Week event on September 17<sup>th</sup> at Grapevine Mills Mall.

4. **FY 2017 Public Works Program Approval.** NCTCOG staff will request the Council's approval of the FY 2017 Work Program. (Samantha Lamanna)

The FY2017 Work Program was approved with no comments.

The Public Works Council discussed some issues regarding fiber-optic cable companies within their cities, and asked NCTCOG staff to bring a Texas Municipal League (TML) speaker to a future PWC meeting. The Council members were curious about the Public Right-of Way in these situations.

New and reappointed Public Works Council members were approved, and NCTCOG staff noted that their terms will begin on October 1, 2016. NCTCOG staff will provide an updated roster at the next PWC meeting.

6. **Sustainable Public Rights of Way.** NCTCOG staff will update the PWC on the activities of the SPROW Subcommittee. (Mia Brown)

Mia Brown (NCTCOG staff) informed the group that two Education Forums are being scheduled for Spring & Fall 2017 and noted that she will send out an email requesting ideas/suggestions to the PWC at a later date.

7. **Public Works Construction Standards**. NCTCOG staff and the Public Works Construction Standards Subcommittee will brief the PWC on the overall progress of the update to the Construction Standards. (Samantha Lamanna)

Samantha Lamanna (NCTCOG staff) informed the group that no major comments were received on Divisions 500 and 600 of the Construction Standards, and that these Divisions have completed the review process. It was also noted that the PWC will see Divisions 700 and 800 in the coming weeks, and that portions of Division 100 are currently under legal review.

8. *integrated* Stormwater Management (iSWM) Activities and Consultant Contract. NCTCOG staff will present an update of iSWM program activities including the recently released Request for Proposals for iSWM services. (Derica Peters)

Kenny Haferkamp (NCTCOG staff) informed the group that Fort Worth and Kennedale are undergoing the review process to become iSWM certified. The City of Frisco has reached Silver designation and will be receiving a plaque and a street sign soon.

Kenny also noted that a Request for Proposals has been released to procure for a new consultant to work on iSWM activities in October. The due date to submit proposals is September 2<sup>nd</sup>.

9. **Other Program Activities**. NCTCOG staff will provide an update on FEMA's Cooperative Technical Partnership Program activities and the Floodplain Administrators/Community Rating System Users Group. (Samantha Lamanna)

Samantha Lamanna (NCTCOG staff) announced that FEMA CTP Discovery meetings will be held in October/November for the Denton/Cedar watersheds. She also announced an Elected Officials/CRS Users Group seminar to be held Wednesday, August 31, 2016. It was noted that this event was moved to a bigger room due to the large number of attendees, including many Elected Officials.

#### **INFORMATION ITEMS**

10. **Public Works Emergency Response Team (PWERT)**. A PWERT representative or NCTCOG staff will give an update on recent PWERT activities. (Samantha Lamanna)

Joe Trammel (Tarrant County) updated the PWC regarding past PWERT meetings, and let the Council members know that the generators and other equipment, bought with previous grant funding, have been distributed throughout the region.

11. **Regional Pavement Procurement.** NCTCOG staff will update the PWC on the status of the procurement for regional vendors to perform pavement analysis services. NCTCOG staff will brief the PWC on the next steps in the process, as well as how PWC members can use this shared service. (Samantha Lamanna)

Samantha Lamanna (NCTCOG staff) announced that the Pavement Analysis Services Contracts have all been executed and that participating entities can now use the Shared Service. It was also noted that entities wishing to use these contracts must be participants in the North Texas SHARE Program. More information can be found at www.NorthTexasSHARE.org.

12. **Texas Public Works Association Update.** A TPWA representative or NCTCOG staff will update the PWC on upcoming TPWA local events and meetings. (Samantha Lamanna)

Jim Proce (City of Rowlett) spoke about attending the TPWA conference in McAllen in June. There were over 40 technical presentations at the conference, and Jim encouraged PWC members to attend the conference next year.

Samantha Lamanna (NCTCOG staff) noted that no Roundtables were currently scheduled on TPWA's website, however there will be a Director's Roundtable on September 22<sup>nd</sup> in Rowlett that will be posted to the website shortly.

13. **Discussion with Frontier.** At the PWC meeting on August 27, 2015, a request was made by the Council to bring in local utility agencies to future meetings for approximately 30 minutes of discussion on field issues and how to coordinate more effectively. The Council will continue this initiative through a discussion with Frontier.

Ryan O'Neil & Stephen Higgins (Frontier) presented information on Frontier's efforts in the region to provide unparalleled customer support in the region. They highlighted information about their customer demographic, their service regions, their operating partners, their proposed solutions for infrastructure upgrades (copper to fiber), and their network/Wi-Fi solutions.

The PWC is satisfied with the amount of utility companies that have come to PWC meetings thus far, and with their quality of discussion.

## OTHER BUSINESS AND ROUNDTABLE DISCUSSION

14. **Future Agenda Items**. PWC Members and NCTCOG staff may suggest future agenda items.

The PWC is satisfied with the utility discussions, and did not suggest another utility company to be brought in at the next meeting.

TML was again mentioned as a future speaker to discuss fiber-optic cable issues.

15. **Roundtable Topics/Other Business**. PWC members and NCTCOG staff may share additional items as time allows.

No attendees had any updates to share.

Samantha Lamanna (NCTCOG staff) announced that she will be leaving NCTCOG in September, and that Kenny Haferkamp (NCTCOG manager) will be the main contact for the Public Works Program and Public Works Council.




