Business Items

- Fort Worth DVE Extension Request
 - Heidi Yaple with the City of Fort Worth presented an Extension Request for their 2021 SHSP DVE Fusion Center Analyst Position to September 30, 2023 due to staffing changes and confusions within the City.
- <u>Motion</u>: Randy Renois made a motion to approve the DVE extension of the performance period for Fort Worth, Randall Gurney 2nd the motion. The motion carried.
- Voting on Carve Out Projects
 - o Maribel Martinez presented the Regional Planning Project for \$465,000 no including the 5% M&A.
 - \$405,000 Staffing & Fringe
 - \$20,500 COG Travel
 - \$10,000 Listservs and Computer Software
 - \$5,500 Office Supplies & Printing
 - \$5,000 Cell Phone & MiFi
 - \$19,000 Meeting Spaces
- <u>Motion</u>: Meredith Nurge made a motion to approve the Carve Out Projects, Rodney Smith 2nd the motion. The motion carried.
- Voting on Scoring Criteria
 - o Nexus to Terrorism: Establishes correlation to terrorism preparedness and/or prevention
 - Regional in Scope: Benefits region as whole vs. few or one jurisdiction
 - o Ongoing Sustainment: One-time or sustained by sub-grantee vs. continued SHSP funding
 - Capability Gap: Need identified in exercise, real world event, and/or THIRA/SPR
 - Reasonable Budget: Amount requested aligns with project
 - Overall Quality: Assessment of project
- <u>Motion</u>: Chase Wheeler made a motion to accept the GY23 Scoring Guidelines and Criteria, Thomas Griffith 2nd the motion. The motion carried.
- THIRA / SPR / RIP Approval by Chairs
 - Seeking approval for REPAC Chairs to approve the Threat and Hazard Identification Risk Assessment (THIRA), State Preparedness Report (SPR), and Regional Implementation Plan (RIP) on behalf of REPAC.
- <u>Motion</u>: Chase Wheeler made a motion to for the REPAC Chairs to approve the THIRA/SPR/RIP before submitting to the OOG, Randy Renois 2nd the motion. The motion carried.
- REPAC Handbook Updates & SME Transitions
 - Transition of REPAC Subject Matter Expert seats to Formal REPAC Working Group representatives over the next 3 cycles.

- REPAC will receive a copy of the REPAC Handbook updates once finalized.
- SME seats will be in rotation.
- SME's must meet to qualify for their grant funds.
- SME seats are transitioning to Working Group representatives.
- Wildland Fire will possibly disband due to lack of participation.
- <u>Motion</u>: Michael Baldwin made a motion to approve the REPAC Handbook Updates & SME Transitions, Randall Gurney 2nd the motion. The motion carried.

Discussion Items

- GY20 & GY21 Close-out
 - Changes to De-obligations / Reallocation
 - The state will not allow extensions on planning projects even if it is for equipment. It is not certain the State will grant an extension.
 - Need to let COG staff know immediately if you run in to problems.
- GY22 Project Update
 - Received \$1.5 million in October 2022
 - Some approved projects include:
 - Interop Regional Interoperable Communications Plan
 - PWERT Will receive trailers
 - Hazmat 7 Day Decon Kits (NEFDA, DFW Airport, Denton, Plano, Richardson, Irving & Arlington)
 - SWAT 3 Communication Headset Projects (DFW Airport, Garland, & Prosper)
 - EOD 4 Unknown Detection Device (NERT, Garland, DFW Airport, & Plano)
- National Cybersecurity Review (NCSR)
 - o Must be completed by your Chief Cybersecurity Officer
 - Takes approximately 4 hours to complete
 - Due by February 28, 2023
 - You can spend on projects, but no reimbursements will be made until this document is complete and the OOG removes the hold on the grant project.
- GY23 Process
 - Will begin next October.
 - We currently do not have a grant guidance, so we will go off what we had last year.
 - o 30% Law Enforcement and 30% National Priorities.
 - o Grant Timeline
 - EPPC is December 1. We will be discussion the EPPC Sub-committee.
 - There will be a Grant Writing Assistance workshop is on December 6.
 - Would like all the working group projects to be submitted by December 30, 2022.
 - REPAC Scoring is on January 11, 2023.
 - REPAC is February 2, 2023.
 - Tentatively projects are due in eGrants mid-February.
- THIRA / SPR / RIP Update
 - The final review meeting is December 13, 2022 at NCTCOG 1:30 pm 3:30 pm.
 - Will have the final documents to COG staff by December 16, 2022.
 - Will be submitted by December 31, 2022.



- Updates to SHSP Funding Allocations
 - Law Enforcement went from 30% to 35%
 - Election Security was added as a competitive National Priority Area
 - Cody Powell is looking into some possible software, security, or firewall projects that can be submitted.
 - FEMA will be holding National Priority Calls over the next few weeks
- GY23 Project Funding & Priority Update
 - Anticipated Allocation of \$1.5 Million. We should know the exact amount and project fundings by June.
 - \$525,000 for Law Enforcement, \$135,000 for National Priorities, \$975,000 for all other projects.
 - The EPPC Funding subcommittee and REPAC chairs reconvened last week to review the allocations since the anticipated amount was a lot less than we were thinking it would be.
 - Individual funding allocation lists to the working groups next week.
 - Additional Funding priorities were also reviewed, if more than anticipated funds are received.
- GY23 SHSP Grant Application AAR Meeting
 - The next AAR meeting is scheduled for February 22, 2023, 1:30 pm 3:30 pm in the Pitstick conference at COG
- Replacement of SME Seats Update
 - We will begin the SME seat replacements to working group seats this year. Nominations for the chosen working groups will open up at the May meeting.
