1. **Welcome and Introductions.**

3. **FY2026 Work Program Update.** NCTCOG will share an update on the FY2026 Work Program, invoicing process, and anticipated tasks.  
  
NCTCOG informed attendees that invoices were distributed via email in late December 2025. If you did not receive an invoice or have questions about participation in the WATER Work Program, please contact Hannah Ordonez at [hordonez@nctcog.org](mailto:hordonez@nctcog.org). NCTCOG also shared that cost-sharing amounts are expected to remain the same, based on the 2026 NCTCOG Population Estimates.
4. **Holiday Grease Roundup Update.** NCTCOG will provide an update on the 2025 Holiday Grease Roundup.  
  
NCTCOG provided an update on the 2025 Holiday Grease Roundup, which is slated to conclude on January 31, 2026. This year, the Holiday Grease Roundup had 49 participating partners. A post-event survey will be distributed to participating partners in February 2026.
5. **Defend Your Drains North Texas Promotional Activities Discussion.** NCTCOG will provide an update on activities and analytics from the Defend Your Drains website and social media activities. NCTCOG will also provide an update on the Vietnamese educational explainer video translations.  
  
NCTCOG shared that the Vietnamese translations and voiceovers for the wastewater educational explainer videos are complete and is aiming to have all ten videos completed by Fall 2026. NCTCOG also provided a brief update on social media and website traffic.
6. **Municipal Staff Training Discussion.** NCTCOG will seek feedback from attendees on potential training topics.

Attendees discussed the need for a workshop or panel discussion on wipes education, including a session on why wipes are a large issue for wastewater facilities and then an open-floor discussion on successes and challenges for educating the public about the issue of wipes in pipes.

7. **General Updates.** NCTCOG will provide general updates on relevant programs and events.

The WIPPEs Act (Wastewater Infrastructure Pollution Prevention and Environmental Safety Act) has been introduced to the Senate in September 2025, with no further action.

The Total Maximum Daily Load (TMDL) Program is seeking feedback on the revised Implementation Plan Strategies. **Strategies 1.0 Wastewater and 5.0 On-Site Sewage Facilities** are posted on the TMDL Coordination Committee webpage for review. The North Texas Municipal Water District had a successful Holiday Grease Roundup event through additional social media posts and other efforts. NTWMD will also be hosting a ribbon cutting event for their newest wastewater facility in New Hope, TX and offered to host a future WATER meeting at this location.

The City of Frisco shared information about their recently launched composting program, which collected 90 pounds of compostable material in the first two days of the program!

The Texas A&M Forest Service has grants available for Community Forestry, including grants for Municipal Forests, Workforce Development, Watershed Protection Implementation, and more. The City of Keller has collected double the amount of cooking oil/grease in this year's Holiday Grease Roundup as compared to last year's event.

The City of Arlington expressed additional participation in their Holiday Grease Roundup but also expressed concerns with the customer service from the current grease collection vendor partner.

The City of Lewisville shared some of their practices from this year's Holiday Grease Roundup, including the addition of a QR code survey at their drop off location for participants to be entered into a prize.

The City of Mansfield will be starting tours of their pump stations and water tours to small groups soon.




