






Typical Section LT JG Barnett




PROPOSED LTJG BARNETT ROAD TYPICAL SECTION

Typical Section Meandering Road




EXISTING MEANDERING ROAD TYPICAL SECTION




PROPOSED MEANDERING ROAD TYPICAL SECTION



Key Intersection Meandering Road at LT JG Barnett Rd





Item 4 Update on 10th Air Force Civic Leader Tour

10th Air Force Overview

- Headquartered at NAS Fort Worth JRB
- One of three numbered air forces in the Air Force Reserve Command
- Responsible for command supervision of 17 units some highlighted below
 - 301st Fighter Wing NAS Fort Worth JRB
 - 482nd Fighter Wing Homestead ARB, Florida
 - 920th Rescue Wing Patrick AFB, Florida
- 20,000 reserve, active duty and civilian personnel at 37 military installations
- Diverse operations: fighter and bomber operations and training, special operations, rescue, airborne warning and control, combat air operations battle staff, remotely-piloted aircraft, space, cyber, intelligence, surveillance and reconnaissance units









Homestead Air Reserve Base / 482nd Fighter Wing

- 482nd FW is the host unit for Homestead
- 2,400+ military and civilian employment
- 2,000 acres, 11,201ft. Runway
- 28 F-16 Fighting Falcons
- 6 additional tenant units
 - 125th Fighter Wing, Detachment 1 of the Florida Air National Guard (F-15)
- \$331 million economic impact











315th Airlift Wing





- Based at Charleston AFB
- Mission: To provide and deliver global combat-ready C-17 airlift, expeditionary combat support and aeromedical evacuation anytime, anywhere
- Approx. 2,600 military and civilian personnel
- 51 C-17 Globemaster III aircraft



Patrick Air Force Base

- Operated by 45th Space Wing, includes Cape Canaveral
- 74 mission partners and tenants
- \$1.12B economic impact
- 15,000+ personnel
- 48 space launches per year





920th Rescue Wing

- Combat search and rescue unit
- 2,000 Citizen Airmen
- Served as primary rescue unit for NASA space shuttle missions
- Pararescumen (PJs)

Item 5 JLUS Implementation Grant Update

Overview

- Joining Forces study completed in 2018
- Over 150 strategies identified, both regional and installation-specific
- JLUS Implementation Grant to be sought from Department of Defense, will require local match
- Need to confirm need and prioritization of implementation activities and identify implementing entity for each activity
- OEA Guidance: Need to connect to added value to DoD, no other resources for grant funds being requested, connect back to original JLUS grant issues to be addressed – average amount \$200,000 over 18-24 months

Original JLUS Grant Issues

- Maintain, foster and grow outstanding relationships with NAS Fort Worth JRB and surrounding local communities
- Protection of key military training areas from incompatible development, including wind energy projects and cumulative effects of noise complaints
- Monitor additional residential growth in the noise contours, but also near other military installations
- Prevention of incompatible development surrounding other North Texas military installations
- Best practices, low impact development strategies and preventive measures related to airfield flooding

- Local Planning and Encroachment Protection
- Sound Attenuation Measures
- Economic Development Focused on Joint Use Facilities and Increasing Installation Capabilities
- Aviation Issues Including UAS and Airspace Trends

- Public Information
- Grant Management

- Construction anticipated 2023




Regional Veloweb Trail Network Loop


Regional trail corridor in western Fort Worth and Westworth Village to cross major highways and connect:

Bomber Spur Regional Trail (South of IH 30)




RFP for Trail Preliminary Engineering underway (3 miles from W. Vickery Blvd. to Calmont Ave.)
