## Item 3: Group Discussion

Meeting attendees were asked to share any other resources they know would pertain to air quality and health efforts:

- Sala Senkayi, EPA, shared information on the EPA's Source Assessment Mapping Interface for Environmental Health Data Visualizations Interface (SAMIEHD-Vis)

## Additional comments:

- Air quality and health data existing on different platforms with different groups makes it difficult to create a useful regression analysis equation that quantifies risk to determine where best to focus air quality/health initiatives.
- Support for NCTCOG to be the regional entity to implement the necessary steps to support this data integration.
- There is an interest in reaching out and communicating with those who work with athletics and kids (athletic trainers/coaches/school nurses/etc.). Analisa Garcia (NCTCOG) to follow up with Leslie Allsopp (Asthma 411) to explore possible opportunities.

Meeting attendees were asked to share any updates on current projects they are working on that they would like to share or if they were seeking any support.

- Freddie Ortiz, City of Dallas, shared that D-CAMP is looking to learn how to better interpret the
  data from their non-regulatory monitors and developing an outreach program to discuss D-CAMP
  with the community by conveying highly technical air quality information in a more digestible
  format for the public and those working in other sectors.
- Leslie Allsopp, UNTHSC, shared they are taking steps to access the TX DSHS Texas Health Care Information Collection (THCIC) data to evaluate and integrate this health data with available regional air quality data. Leslie is open to connecting with anyone who is interested in taking part in this effort.
- Richard Perez, Northside Fort Worth, shared they are continuing to expand their Air Gradient Hyper-local air monitors. The latest monitoring shows better air quality in Westside Fort Worth regarding PM, TVOC, NOx, and CO2 compared to their Northside Fort Worth Monitors.
- Kaitlynn Davis, City of Denton, shared they are currently working on building a public-facing dashboard displaying air quality data from their neighborhood-level non-regulatory monitors in the city. They anticipate the dashboard pilot to be live in a few weeks. Kaitlynn will forward more information as it becomes available.
