Stormwater BMP Library

A little background:

- ❖ BMP Library is the brain child of the technical subcommittees for the Bacteria TMDL Implementation Plan Project.
- ❖ Because there aren't a lot of bacteria-specific BMPs, the goal was to collect them and put them in one location for all the MS4s within the impaired watersheds.
- ❖ Since the Library's original concept came about, the project has morphed to be more useful for all Stormwater Program participants and now will incorporate BMPs covering, not just I-Plan specific strategies like pet/livestock waste, but also permit requirements like the minimum measures.
- ❖ Would coordinate with the current Stormwater BMP web page(s) for one web location simplicity.
- ❖ Bacteria-specific BMPs would be highlighted.
