The 2024 International Building Code Amendments were passed unanimously with no additional changes.

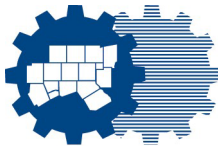
The 2024 International Existing Building Code Amendments were passed unanimously with no additional changes.

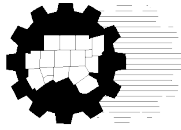

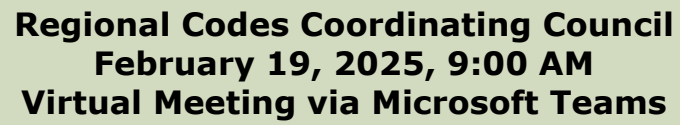
3. **Schedule for the Next RCCC Meeting.** The next meeting date is tentatively scheduled for July 2025 at NCTCOG Offices.
