

Holiday Grease Roundup Updates


- 9,080 gallons of grease collected from 52 participants/61 drop off locations
- 2025 HGR dates: November 17, 2025 January 8, 2026
- Post-Event Survey Marketing Needs:
 - Instructions/signage for grease collection containers
 - More football/gameday themes in posts
 - Updated outdoor directional signage
 - More content on postcard/half page flyer, additional flyers
 - More HGR logos
 - Branded merch (t-shirts, hoodies, etc.)
 - Is there a need for paid advertising, via billboards or other forms for the HGR?

Holiday Grease Roundup Updates

- Other Post-Event Survey Needs:
 - Better communication from grease collection vendor
 - Potentially seeking additional, vetted vendors for grease collection
 - More locations for grease collection looking to underserved areas
 - Earlier access to marketing materials, website posting, etc.
 - In depth guide for first time participants
 - Peer-to-peer information sharing: what has and hasn't worked for promoting the event?
 - Standard survey for participants dropping off grease/cooking oil




Defend Your Drains North Texas Promotional Activities

- No change to social media traffic:
 - 257 post engagements and 3,654 post impressions across all platforms (Jan-Mar 2025)
- NCTCOG has restarted Google Advertising on April 1st
 - Currently only Google Search ads
 - Intention to start Google Display ads in Fall 2025 to coincide with the HGR
- Spanish video translations still under finalization




Defend Your Drains North Texas Website Traffic



January 1 – March 31, 2025 Website Traffic:

- Most are direct links to site, followed by organic search
- Steep drop-off of visitors after Holiday Grease Roundup
 - October December traffic: over 5,500 visitors

Defend Your Drains North Texas Website Traffic



April 1 – 15, 2025 Website Traffic:

- Large increase with paid advertising
- 32,000 visitors in 2 weeks as compared to 2,600 visitors in 3 months
- Average engagement time significantly dropped – plans to make website changes to help increase

- \$84,400 committed through 4/15/25
