### **ACTION ITEM**

2. Meeting Summary. The July 1, 2020 meeting summary will be presented for approval.

Larry Patterson, UTRWD, made a motion to approve the July 1, 2020 meeting summary, and Greg Dickens, City of Hurst, seconded the motion. The motion passed unanimously.

#### **PRESENTATION**

- 3. U.S. Army Corps of Engineers Regulatory Program Recent Changes. Chandler J. Peter, Regulatory Technical Specialist, Regulatory Division, Fort Worth District, U.S. Army Corps of Engineers, will highlight recent changes that have occurred to aspects of the program including the revised interpretation of waters of the U.S., newly proposed nationwide permits, 401 water quality certification process, and modified National Environmental Policy Act regulations.
  - U.S. Army Corps program changes are expected to continue through 2021 and even 2022. Ephemeral features are no longer jurisdictional under the definition of waters of the U.S. This will have a big impact in our region. The regulatory changes will also impact statewide flood planning efforts. See the presentation slides for more information.

- **5. 2021 Water Resources Questionnaire.** The WRC will be asked to provide input on the topics and questions to include in the annual regional water resources survey that will be distributed in early 2021.

The WRC suggested keeping the questionnaire short. No other comments were provided.

6. Water Resources Education and Outreach. The WRC's input will be sought on topics for the webinars or workshops that NCTCOG hosts at least once per quarter. Additionally, NCTCOG will request ideas for water resource outreach activities that can be performed safely during the ongoing pandemic.

For outreach items, the WRC suggested newsletters. For webinar topics, the WRC suggested the following:

- Regulatory, water quality, and water conservation programs;
- TRWD as a possible presenter on conservation;
- Specific watershed protection plans;
- Reduction of single use plastics and containers at restaurants; and
- Fats, Oils, and Greases

The final 2020 WQMP was approved by TCEQ on September 13, 2020 and can be found on NCTCOG's website <a href="here">here</a> under the green "Water Quality" banner as a Story Map Journal.
  - **b. WQMP Subcommittee Meeting** The WQMP Subcommittee will meet on November 17, 2020 at 9:00 a.m. to continue its discussion on how to improve the content and data included in the annual updates to the WQMP.
  - **c.** Water for North Texas Resource Library. NCTCOG staff will provide an update on the status of this website.
  - **d. U.S. EPA Trash Free Waters Grant.** NCTCOG was one of 17 entities awarded a grant from the U.S. Environmental Protection Agency's Trash Free Waters program, which focuses on the prevention and removal of litter in waterways as well as outreach


**9. Roundtable.** WRC members are invited to share what is happening in their communities.


