ACTION/DISCUSSION/PRESENTATION ITEMS

- 1. **Welcome**. Ron McCuller welcomed the Water Resources Council (WRC) members, interested parties and NCTCOG staff.
- 2. **Summary of the June 14, 2012 Meeting**. Richard Talley made a motion to approve the June 14, 2012 meeting summary. Larry McDaniel seconded the motion. The WRC was unanimous in its approval.
- 3. Water Quality Management Plan for North Central Texas. Sam Brush and Doug Anthony reviewed various aspects of the EPA Quality Assurance Project Plan (QAPP) that was incorporated into the Water Quality Management Plan (WQMP) at the direction of the Texas Commission on Environmental Quality (TCEQ). EPA is currently reviewing the WQMP for completeness.
 - The 2012 WQMP contract is being completed and it is expected that the 2013 contract will follow the same plan. The projected budget for Fiscal Year 2013 is \$98,000.
- 4. **Draft 2012 Texas Integrated Report Available for Public Comment**. TCEQ's deadline for public comment is November 19, 2012. The document sections are available online at http://www.tceq.texas.gov/waterquality/assessment/12twqi/twqi12.
- 5. Section 408 Expedited Project Review. The U.S. Army Corps of Engineers simply does not have the funding or staff to promptly review the Section 408 project applications for federal navigation and flood control projects. To overcome this, they propose that an applicant wanting their application expedited pay a fee to cover staff costs for the review. This approach would be strictly voluntary. USACE asked NCTCOG to participate by assembling an impartial review team that would determine the evaluation structure and rank applications that wish to be accelerated.
- 6. There Are No Review Items for This Month. NCTCOG staff completed a 208/201 coordination review item for the City of Grand Prairie and transmitted it to TCEQ. The project was for improvements to a section of sanitary sewer pipeline.

- 7. **Total Maximum Daily Load Bacteria Implementation Plan**. The peer review draft was submitted to TCEQ for their internal review. Their comments are anticipated in the coming month. The next major deadline is January 15, 2013 when a draft response to the initial TCEQ comments will be submitted.
- 8. **NCTCOG TCEQ 319 FY2013 Project Proposal Status**. NCTCOG received notice from TCEQ that the Lake Arlington Watershed project has been approved to move forward.
- WRC Roundtable Topics, NCTCOG Programs, and Environmental Activities.
 NCTCOG staff reported that the Texas Department of Agriculture is currently reviewing the
 Texas Community Development Block Grant applications and will score them in
 January 2013.
- 10. Schedule for Next Meeting of the Water Resources Council. The next WRC meeting is tentatively scheduled for Thursday, December 13, 2012.
