Discussion Items

FY20 Homeland Security Grant Update

NCTCOG Staff

- FY20 grant projects are currently active.
- COG staff are currently working to reach out to working group chairs to establish
 deliverables for projects containing contracts. We are already 6 months into the projects
 and meetings will be scheduled to get the projects going to meet the period of
 performance deadlines.
- Due to the ongoing response operations, we understand the difficulties with attending working group meetings. However, to ensure the SHSP programs continuity, it is essential to maintain regular participation amongst the working group members.

Cybersecurity Working Group

NCTCOG Staff

- The Cybersecurity Working Group is struggling to maintain regular participation from regional jurisidictions.
- Recent cyber attacks not only affected multiple jurisdictions across the state of Texas, but also across the US. There have been past cyber attacks in the region that are still working to get back to normal.
- DHS has placed increased importance on the identification of cyber security capability gaps.
- The Cyber Security Working Group is putting together an RFP for a contractor to facilitate the creation of an incident response recovery template that consist of a consolidated list of standards and a maturity model for jurisdictions.

HSGD Program Changes

- On February 19th, DHS released the "Notice of Funding" opportunity for the Homeland Security Grant program.
- Program changes are as follows:
 - Enhancing Cyber Security requires 7.5% of our overall allocation.

- Enhancing the protection of soft targets/crowded places changed from 7.5% to 5% of our overall allocation.
- Enhancing information and intelligence sharing and cooperation with federal agencies, including DHS was reduced to 5% of our overall allocation.
- Addressing emerging threats was reduced to 5%.
- Combating Domestic Violent Extremism (DVE) was set at 7.5% of our overall allocation.
- EPPC was provided this information during the EPPC Sub-committee Funding meeting.
- Based on the discussion with the OOG, we feel strongly that the Fusion and Public Education projects submitted would qualify to be moved to the Domestic Violent Extremism National priority area with minor adjustments.
- o What is Domestic Violent Extremism:
 - Open source analysis of misinformation campaigns, targeted violence and threats to life.
 - Sharing and leveraging intelligence and information, including opensource analysis
 - Execution and management of threat assessment programs to identify, evaluate and analyze indicators and behaviours indicative of domestic violent extremists.
 - Training and awareness programs (through social media, suspicious activity reporting [SAR] indicators and behaviours) to help prevent radicalization.
 - This also applys to the UASI side of projects.
 - Any projects submitted under Fusion, Intel, or DBE must remain separate.

FY21 SHSP Timeline and Path Forward

- Project scoring results from the REPAC Scoring Meeting is posted in the power point presentation.
- On March 15th, the OOG will batch the applications back to the COG (already received).
- For prioritization and funding based on the EPPC Funding Sub-committee, recommendations which will then be submitted back to the OOG by March 31st.
- We expect the OOG to make some adjustments to our projects due to the national priorities changes.
- The project funding amounts will be released once the OOG has finalized the funding allocations at a later date. After Action Review Committee Meeting Sign-up
