Trinity River National Water Trail

All but 2 sections are 4-6 miles in length

- One 12-mile section
- One 24-mile section
- New expansion sites will shorten some of these distances

The Trinity River Paddling Trail consists of 130 miles of river accessed by 21 official launch sites. The paddling trail traverses 9 municipalities including Dallas and Ft. Worth, and is located in the middle of America's 4th largest metro area with a population of 7.5 million people. Over 5 million people live within 30 minute drive of the trail.







Paddling Trail Status February 2023

Currently 19 out of 21 launch sites are open.

- One launch site is getting difficult to use
- Loop 12 closed flood damage and safety concerns
- The access path to the Dimension Tract launch in Carrollton got washed out and became unusable -Thank You Carrollton for the quick repair!







Trail Expansions

- New Beltline canoe launch
- New Viridian canoe launch
- New launch at Riverside Park in Fort Worth in planning stages
- Trinity View Park canoe and kayak launch summer / fall 2023
- Lewisville Lake Paddling Loop
- Talks ongoing about adding USACE boat ramps on Corps lakes


Trail Section Location: River Legacy Park, Arlington, TX. Collins Street entrance: 3020 N. Collins St., Arlington, TX 76006. Latitude / Longitude DD: 32.788243° -97.100328° Directions to Trail: Take the Collins St exit off I-30. Turn North on Collins St. Continue North on Collins St. The entrance to the Park will be on your left after Green Oaks Blvd. Launch Parking and ramp is on your left ~1000ft from the park entrance. Launch Description: Long gentle slope to a concrete boat ramp. Distance and Take-out: 24 miles, the take-out is Trammell Crow Park. Trail Description: The put-in is boat ramp at River Legacy Park. This is a winding river with moving water - some small rapids & riffles. Mostly gravel bottom. The take out is a concrete boat ramp. River Gauge:



Paddling Trail Usage February 2023

- The trail has been usable, except:
 - One day in April 2022
 - Approximately 3 weeks in May and June 2022
 - A few days in August 2022 where the river was 27 ft in Dallas
- The section between LLELA and Hebron Parkway has a tree blocking the river making it unpassable during very low water flows

Vision for the Trail

- To assemble the various segments of the Upper Trinity River in North Texas into a fully integrated paddling trail
- The Trinity River Water Trail covers 130 river miles, over nine cities and three counties, and 21 launch sites along its length with access to 3 river tributaries and the main branch
 - Clear Fork
 - West Fork
 - Elm Fork




Goals for the Trail




Trinity River Trail Map


