1. **Welcome and introductions.**

The meeting began at 9:30 a.m. with introductions of all present.

## DISCUSSION/PRESENTATION/ACTION ITEMS

2. **Meeting Summary.** The March 28, 2018, meeting summary is available online for review. Comments will be sought at the meeting. (Mia Brown)

The Summary was approved as presented.

3. **FY 2018 Training Discussion.** NCTCOG staff will solicit feedback on completed FY 2018 Dry Weather Field Screening Basic Training and the Industrial Inspectors Workshop. (Mia Brown)

The Task Force overall had positive feedback for both trainings. Specifically for Dry Weather Field Screening Basic Training, the group requested that both the indoor and outdoor portions of testing kit use slow down to give attendees more time with the kits.

4. **IDDE Field Guide Printing Options.** NCTCOG staff will solicit feedback on printing options for the updated 2018 IDDE Field Guide.

The Task Force indicated they would like a different binding option for the new printing, possibly one hole with ring or carabiner instead of a 3-hole punch requiring a binder. The Task Force also selected a new cover photo for the 2018 version of the guide.

5. **FY 2019 Work Program Overview.** NCTCOG staff will discuss the approved 2019 work program with the Task Force.

Mia Brown asked the Task Force for more specific details on what they would like to see in the automotive related business materials that are part of the FY2019 work program. They requested basic information in a flyer format such as: What is an ARB? How does this impact you? What is stormwater? They also requested the flyer be very visual, describe what constitutes a violation, have a placeholder for city-specific ordinances, and that it be available in both English and Spanish.

## OTHER BUSINESS AND ROUNDTABLE DISCUSSION

6. **Roundtable Topics/Other Business.** The IDDE Task Force members and NCTCOG staff may share additional items as time allows.

Marissa Paz, City of Addison, announced she will be leaving this month and introduced Shawn Cheairs, her replacement.

Krista Pender, City of Carrollton, noted that the city is currently working on dry weather field screening.

Brigette Gibson, City of Arlington, is working on a water quality GIS-based map that identifies IDDE hot spots. She asked the group if any of them are working on a similar project. Southlake uses Google Maps. Duncanville uses the Arc Collector app for its field staff, which allows them to add a picture in real time to the shapefile.

Duy Vu, City of Cedar Hill, noted that they received an EPA audit in May for all MCMs, and that five staff from the EPA attended.

Jon Bunner, City of Duncanville, announced that they received a three-year TCEQ inspection.





