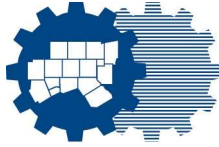
HB 1059 relating to a biennial report on stormwater infrastructure in this state was vetoed by the Governor on June 15, 2019.

- Tarrant County: Received letter from TCEQ re: delinquent Core Data Sheet; several counties gathered for a roundtable prior to submitting SWMP's, it was a good information exchange; have started quarterly meetings with Public Works, Engineering and other relevant departments to encourage engagement with peers
- Mansfield: Submitted SWMP on deadline date, so have not heard back from TCEQ; get in touch with the permit writing team (of TCEQ) to let them know if you support the proposed changes that were discussed at the Region 6 EPA Stormwater Conference
- Cedar Hill: the TX State Alliance for Recycling conference will be in San Antonio this fall
- Frisco: no new items
- Irving: permit is still under review
- Arlington: business as usual; city has an opening for a Stormwater Engineer on the Capital Improvement Projects team
- Fort Worth: new to the position – is looking forward to working with the Committee; city has issues with blue/green algae – How have others been testing their water and dealing with this issue?
- Plano: no new items
- Carrollton: Had to make changes to their Core Data Sheet per TCEQ
