6. **Roundtable Programs.** NCTCOG staff will present information on the remaining Post Construction Inspection roundtable event.

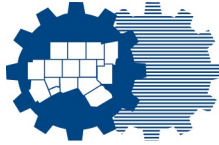

City of Mesquite – no update

City of Lewisville – SWMP approved in April , still waiting on Intent to Publish

Dallas County – had our first cleanup event that focused on the Unincorporated Area of Dallas County on Saturday August 7th. It was a success and we are looking into doing it more often.

City of Frisco – no new updates, would like to see future hybrid meetings but will probably attend only 1 in person.

Tarrant County – Our MS4 SW Permit was reviewed by a TCEQ intern who left the agency on 8/13/21. We are beginning to write our rebuttal to that review.

DART – no updates

Colin County – no response from TCEQ on SWMP, moving forward with submitted plan.

City of Cleburne – in-person meetings are iffy due to city restrictions, wants to/has signed up for the North Tx Clean UP Challenge, Julie will be retiring soon

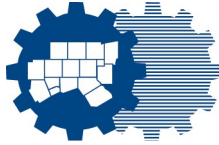
Texas A&M Forest Service Urban Water Resources – no updates
