- 4. FY2022 Work Program.** The NCTCOG staff will discuss on-going, and planned task force activities and other components of the regional stormwater management program. Topics include:

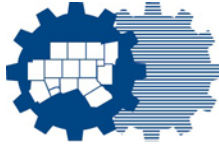

7. **Future Agenda Items.** RSWMCC Members and NCTCOG staff may suggest future agenda items.

Amesha Morris, City of McKinney, requested a future update on where members are with their post-construction programs.

8. **Roundtable Discussion.** Discussion of activities within individual jurisdictions and the format of future meetings as time allows.

Plano: The Pollution Prevention videos that NCTCOG created are outstanding and help meet BMPs. Erosion inspections have been transferred from Engineering and Building Inspections to Engineering and Stormwater Quality. There is an Industrial Inspector position opening soon after the holidays. Working on the Annual Report and submitted permit reissuance with no word back from TCEQ.

Frisco: Heard from TCEQ on the SWMP they sent several years ago regarding the months of a program they were implementing. Sent back a response to TCEQ but have not received approval yet.

Lewisville: Still waiting to hear from TCEQ on the SWMP submission; made revisions a year ago. Preparing to start work on the Annual Report. On Monday, Lewisville annexed Castle Hills, adding about 30,000 new residents, which jumped them into the top 25 largest cities in Texas. Will be busy incorporating this increase in urbanization into the SWMP.

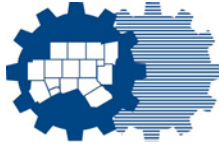
Mansfield: Pollution Prevention training videos have been used to train people in other departments. Staff likes the fact that it emails a confirmation when the training is completed. Have instructed city staff to enter Julian's name and email as the supervisor so those records come straight to him for recording keeping.

McKinney: Still in process of getting any form of notification on the SWMP from TCEQ. Have yet to have a review processed. Reached out to TCEQ for clarification on questions staff had about the post construction program. Have posted an open position for a Stormwater Construction Inspector.

Dallas County: SWMP has been approved by TCEQ! Went back and forth with TCEQ on a few things but those were straightened out and the SWMP has been approved.

Tarrant County: Mitchell Carpenter has taken over Becca's position at Tarrant County. Robert Berndt has recently announced his retirement. His position, Environmental Specialist with the Transportation Department, will be posted soon.

Cleburne: Recently completed 3 MSGP renewals. Still receiving NOIs. Would like to know if anyone includes MSGP positions on a GSI map? (See responses from Arlington and Denton) Have an electronic recycling collection this week and encourage others to check out the Bluebonnet RC&D. Robert Berndt, Tarrant County, is on the board of Bluebonnet and will finish out the remainder of his term after his retirement from Tarrant County.

Arlington: Nothing to report but, in response to question posed by Cleburne about mapping, Arlington uses a software program called MS4Front to map NOIs and NECs. Info can be pulled up while out in the field.

Denton: Still waiting on SWMP to be approved by TCEQ, waiting for notice to post for public review. Also waiting on pesticide permit renewal, the pesticide general permit expires on January 31, 2022. Have an open position for a Stormwater Inspector – Construction Sites. In response to question by Cleburne, Denton uses a software called CloudCompli to track NOIs and NECs.

DFW Airport: No further updates from TCEQ since last spring when received informal approval of SWMP. Have several Stormwater Resources Department positions open – Environmental Analyst and Project Manager.

Irving: Have several open positions trying to fill, working on the Annual Report based on old permit. Have received no updates from TCEQ.

Grand Prairie: Have two positions that will be opening soon – Stormwater Inspector and Industrial Inspector.

Dallas: Working on Annual Report.

Fort Worth: Working on floatable control initiatives and the waterwheel. Have an open position for a Sr. Environmental Specialist which closes on November 17th. Will be posting another position, Environmental Manager, this week.
