- **Pollution Prevention Task Force**  
 Training Modules:  
 NCTCOG staff is still in process of filming required footage; We will notify you if additional footage/sites are needed. By July expect to have video drafts ready for: Fleet Maintenance & Material Handling; Streets & Drainage Maintenance  
 Next will be:

  - **Illicit Discharge Detection & Elimination Task Force**  
 A flyer and tri-fold for automotive related businesses are currently under development. A third draft will be sent to the Task Force in advance of the July meeting for review and final comment.  
 Basic and Advanced Dry Weather Field Screening Training  
 Basic DWFS Training will be held June 20th at Josey Ranch Lake Public Library in Carrollton. Registration is still open! [www.nctcog.org/envir/events](http://www.nctcog.org/envir/events).  
 Advanced DWFS training will be held in September at Josey Ranch Lake Public Library in Carrollton. Specific date TBD.
  - **Stormwater Monitoring Program**  
 The Annual Regional Wet Weather Characterization Program Monitoring Report for North Central Texas was transmitted to TCEQ on March 1, 2019.  
 Atkins is drafting a stormwater BMP analysis plan. After NCTCOG staff has reviewed the plan, it will go out to Council members for review and comments.

  - **County Stormwater Manager's Roundtable**
  - **2019 Regional Stormwater Management Program Survey**  
 NCTCOG staff presented the responses received so far to the survey that was sent to members to solicit challenges, needs, interest from NCTCOG members in current Regional Stormwater Program activities and potential new activities. The survey will remain open until May 24<sup>th</sup>.  
 NCTCOG staff will incorporate feedback into the Draft FY2020 Work Program and bring back to Council for consideration

## 5. Other NCTCOG Program activities:

- **Integrated Transportation And Stormwater Management Project**  
 A working group of partners and stakeholders to carry out a comprehensive planning effort in Wise County and portions of Dallas, Denton, Ellis, Johnson, Parker, and Tarrant counties. Comprehensive, collaborative planning will dissolve silos and improve delivery of consolidated, adaptive infrastructure before expected population growth makes addressing these issues more difficult and costly. This project is still in the planning phase, and will be a joint Transportation and Environment and Development Departments project with partnerships in the region.
- **Integrated Stormwater Management (iSWM) Program Activities**  
 Two documents were provided at the meeting for review and comments. Please have comments back to NCTCOG staff by **May 24th**. NCTCOG staff discussed the use of Atlas 14 for calculations.

6. **FY2020 Work Program.** NCTCOG staff will request input and discussion of the draft FY20 RSWCC activity.

A draft FY2020 Work Plan was discussed. NCTCOG staff will make changes based on Committee discussion and email to the members prior to the next meeting.

7. **FY2020 Cost Share.** NCTCOG will notify members of the FY2020 cost shares for the program.

The FY2020 Cost Share is the same amount as FY 2019. Commitment forms will be posted to the website soon.

8. **FY2020 RSWMCC Reappointments and Appointments.** NCTCOG will discuss the process for committee reappointments. In June, committee members with expiring terms will receive notification that his/her term is expiring. The individuals nominated for appointment and reappointment will be brought to the RSWMCC for approval at the August 14, 2019 meeting.

Reappointment nomination emails will go out in June for terms expiring September 30, 2019. The full slate of members will be presented at August's meeting, and Officer election will occur at August's meeting.

### OTHER BUSINESS AND ROUNDTABLE DISCUSSION

9. **Roundtable Discussion.** Discussion of activities within individual jurisdictions and other topics as time allows.

- Mansfield: Member is chair for EPA stormwater conference. Please attend and submit abstracts if you would like to speak.
- Frisco: working on an HOA guidebook to help HOA's manage and maintain common areas. Looking for input from anyone else that has something similar they can borrow from.
- Dallas: TMDL study and White Rock Creek sampling
- Dallas County: working on stormwater management plan which is keeping them really busy. Please send examples of your county SWMP for review.
- Tarrant County: EPA Region 6 interim director is speaking to the STEP group at their July meeting in Grapevine. Went to Belton for the TCEQ workshop on MS4. Found out that they are going to be picky. Is open to sitting down with other communities to share what they have learned. In past have tracked how many HHW's they sent out and spent a large part of the time tracking which will not suffice anymore. TCEQ wants to measure things and measure impacts. Found out that you now have to fill out a new core data form each time. That form is on their

website but not under the stormwater section. The NOI form is doing a better job at saving info that you are typing, however, print it out and make sure that it will all be viewable to TCEQ. If not, you will want to attach as an appendix. Around first week of June want to get everyone together to discuss...

- DART: DART is doing a project where they are renovating/updating 28 stations which are less than 1 acre each; therefore, don't have to do construction permits. But internally will follow stormwater BMPs. Starting in Plano and will move into Dallas.
- Lewisville: annual report was submitted. Now working on SWMP. City is working on updating 1980's Development and Drainage manuals. Interested in adopting iSWM. TxDOT will be coming out and looking at the BMPs and SWMP for an upcoming Trail project.
- Carrollton: working on SWMP and specific things they can measure. Working on a lot of creek clean-ups because have a lot of floatables right now. Have a lot of volunteers. Will have a Stormwater Coordinator position open soon.
- Prosper: trying to get everything done and staying busy.
- McKinney: past month completed and sent their SWMP for approval. Went to city council last night so there may be some comments to incorporate. Figuring out how to integrate reporting with new program called Intergov.
- Cleburne: HHW collection and tire cleanup going on.
